



# Scottish Bus Emissions Abatement Retrofit Programme – Phase 5 (round 2) Application Form



## **Background**

The Scottish Bus Emissions Abatement Retrofit Programme (BEAR) Phases has offered £21M funding to support the costs of retrofitting of over 1100 buses and coaches to Euro VI standard in Scottish Air Quality Management Areas from 2018 to 2022.

For BEAR Phase 5 (round 2), Transport Scotland has committed to providing £3.26 million grant funding for bus and coach retrofitting in 2023/24. This funding is to be claimed in the current financial year.

### **About this document**

This document is the application form for BEAR Phase 5 grant funding and includes guidance to help applicants apply for funding.

This document is one of three that you will need in order to complete an application:

- BEAR Phase 5 Calculator and fleet data spreadsheet

BEAR Phase 5 grant funding constitutes state aid. The Benefit is aligned with the European Commission's De Minimis Regulation¹. This allows organisations to receive up to €200,000 equivalent of De Minimis State aid over any three year fiscal period.

Applicants should be aware that the BEAR Phase 5 grants and eligibility criteria will be reviewed as the programme evolves and therefore may be subject to change. Transport Scotland reserves the right to amend the published guidance during the period of the programme.

Transport Scotland reserves the right to reject an application where:

- an application is submitted late, is completed incorrectly, is materially incomplete or fails to meet any submission requirements which have been notified to the applicants; and/or
- the applicant (including any partners) are guilty of a material misrepresentation or false statement in relation to its application and/or the application process.

Transport Scotland reserves the right at any time:

- not to consider applications other than those submitted in accordance with the requirements of the application process;
- to issue amendments or modifications to the application documents during the application process;
- to publish data on an external website in line with State Aid requirements on aid;

Alternatively, as BEAR vehicles replaced within the 5 year commitment term to facilitate the earlier adoption of zero emission buses would also deliver the environmental and air quality objectives of BEAR, operators would therefore not be precluded from applying for other improvement schemes such as ScotZEB provided all remaining buses/coaches in the operators fleet are of an equal or better environmental standard than the BEAR retrofit vehicles. In such cases operators should write to Scottish Ministers at the above address to gain consent in advance of any change taking place.
