Forth Replacement Crossing – Fife ITS Contract

Update on Intention to undertake minor improvement Works – filter drain at Park Lea

Further to previous communications, I am happy to confirm that the works have been completed on the M90 road network corridor associated with the Fife ITS Contract.

As you are aware, the grassed area of land immediately west of Park Lea is particularly prone to waterlogging. This inherent issue was noted prior to commencement and we have undertaken mitigation steps to deal with the high-water table in this area during the works.

On completion of the works we continued to monitor this area. Based on comments received from various residents on the landscaping works and fencing completed – this has been very successful and the area of land within the fenced area is a marked improvement.

However, we have noted a small area of ponding within the fence boundary and although this does not exacerbate the existing waterlogging issue nor present any significant impacts, we feel further improvements may be of benefit.

We therefore confirm our intention to undertake additional minor works in an attempt to further improve drainage in this area. These works will involve renewal of an existing filter drain within the fenced area.

To minimise disruption, access will be taken from Park Lea across the grassed area to the landscaped area within the fenced boundary. This will allow the works to be undertaken quickly and minimise the need for removal of trees and landscaping newly established.

We anticipate these improvement works should take around three days to complete. The works are scheduled to be undertaken during week commencing 10th December 2012.
