

6 Consultation and Scoping

6.1 Introduction

- This chapter describes the consultation undertaken with statutory consultees, other relevant bodies/organisations, and members of the public in relation to the environmental aspects of the proposed Scheme. A summary of the key issues raised and how these have been taken into account throughout the Design Manual for Roads and Bridges (DMRB) Stage 3 Environmental Impact Assessment (EIA) and design process is also provided.
- The consultation described within this chapter builds upon that undertaken for the DMRB Stage 2 assessment. Further details of this consultation are provided in the DMRB Stage 2 Scheme Assessment Report (Jacobs 2014). Although this chapter focuses on the consultation undertaken in relation to the environmental aspects of the proposed Scheme, it should be noted that the wider project team and Transport Scotland are also undertaking separate consultations throughout the progression of the project.

6.2 Approach and Methods

- Consultation has been undertaken according to the guidance provided in Planning Advice Note (PAN) 1/2013: Environmental Impact Assessment (Scottish Government 2013). Cognisance has also been taken of PAN 81/2007: Community Engagement (Scottish Executive 2007), PAN 3/2010 Community Engagement (Scottish Government 2010), the National Standards for Community Engagement (Communities Scotland 2005) and A96 Dualling Inverness to Aberdeen Engaging with Communities (Transport Scotland 2015).
- 6.2.2 The main aims of the consultation undertaken during the EIA process were to:
 - ensure that statutory consultees, other bodies with a particular interest in the environment, and members of the public were informed of the proposals and provided with an opportunity to comment;
 - collate baseline information regarding existing environmental site conditions;
 - obtain input to the identification of potential impacts and the development of appropriate mitigation;
 - inform the scope of the environmental assessment and Environmental Statement (ES) reporting; and
 - seek consultee input to the design.

Identification of Consultees

- 6.2.3 Consultees relevant to the proposed Scheme were identified as follows:
 - review of consultees involved on other major and recent road projects and previous studies undertaken for the proposed Scheme;
 - review of the list of consultees involved in Strategic Transport Projects Review (STPR) (Jacobs, Faber Maunsell, Grant Thornton and Tribal Consulting 2008);
 - review of the list of consultees involved in the A96 Dualling Programme Strategic Environmental Assessment (SEA) (CH2M 2015) and A96 Dualling DMRB Stage 1 Assessment Report (Jacobs 2015a);
 - identification by the project team environmental specialists of organisations and local environmental groups of importance to their area of expertise; and



- consideration of the scale, size and potential impact of the proposed Scheme to identify those directly affected (e.g. landowners) and those outside of the direct area (e.g. nearby communities) of influence.
- A large number of consultees were identified through this process, as listed in Appendix A6.1 (Consultees). A summary of the relevant information provided by the consultees is detailed in Appendix A6.2 (Summary of Consultation Responses).
- 6.2.5 Landowner consultation has been undertaken throughout the assessment process and has informed the proposed Scheme design. Information gathered through landowner consultation has also been utilised in the land use assessment in Chapter 15 (People and Communities: Community and Private Assets).

Key Stages of EIA Consultation

The key stages of consultation that have been undertaken as part of the DMRB Stage 3 EIA are set out below. It should be noted that consultation is an iterative and on-going feature of the project, so will also continue beyond that reported within this ES.

Screening and Scoping Report

As described in Chapter 5 (Overview of the Assessment Process), the Environmental Screening and Scoping report (Jacobs 2015b) was issued to the statutory consultees in November 2015 to request their comments on the proposed scope and approach to the assessment. Their comments were taken into consideration and incorporated into the design and assessment process, where appropriate. The responses received are summarised in Appendix A6.2 (Summary of Consultation Responses).

Request for Data and Comments

Following on from the consultation undertaken at DMRB Stage 2 a number of consultation letters were sent out in December 2015 and January 2016. These provided consultees with details of the DMRB Stage 2 preferred option and requested relevant information to be taken into account in the environmental assessment. The responses received are summarised in Appendix A6.2 (Summary of Consultation Responses).

Public Exhibitions

- The ongoing assessment work for the proposed Scheme includes a rolling programme of regular engagement with local communities and other stakeholders, which started with the public exhibitions held in February 2012 and November 2013. The DMRB Stage 2 assessment culminated in public exhibitions in October 2014 to present the preferred option for the A96 Dualling Inverness to Nairn (including Nairn Bypass) scheme.
- On 26 and 27 August 2015 two 'Meet the Team' events were held in Culloden and Nairn. Representatives from Transport Scotland's A96 Dualling team and the appointed project team, including the Stakeholder Co-ordinator, were available to answer questions on the design and assessment work being carried out as part of DMRB Stage 3 design development process.
- 6.2.11 In February 2016 a series of drop-in sessions were held in in Culloden and Nairn with over 750 people attending. The dates and locations of these sessions were:
 - 3 February, Culloden (189 attendees);
 - 4 February, Nairn (337 attendees); and
 - 5 February, Nairn (233 attendees).
- 6.2.12 All sessions were hosted by Transport Scotland with support from members of the project team. These sessions provided an update on the proposed Scheme, which included a number of proposed changes to the DMRB Stage 2 preferred option following ongoing design development



work and feedback as part of the ongoing consultation process. Drop-in session visitors had the opportunity to provide their comments via a comments sheet or by post or email, and this feedback was provided to the project team. Verbal comments and queries were also captured by the teams.

6.2.13 The primary areas of concern identified from the Drop-in session feedback were in relation to the proposed Scheme design at the Balloch Junction, Gollanfield and the Nairn East Junction. The public raised concerns over the potential environmental impacts at these locations including potential visual, noise and air quality impacts. There were also a significant number of positive responses in relation to the Non-Motorised User (NMU) shared use path proposals.

On-going EIA Consultation

Stakeholder Forums

- 6.2.14 Four stakeholder forums have been used throughout the DMRB assessment process, which aim to bring together groups with similar interests and facilitate a two-way flow of information regarding the proposed Scheme and the wider A96 Dualling Programme. The forums have met throughout the design and assessment process and will continue to meet going forward.
- The forums are the Community Council Forum, the Non-Motorised User (NMU) Forum, the Environmental Steering Group (ESG) and the Local Authorities and Regional Transport Partnerships Forum. Details of the meetings held with these forums for the DMRB Stage 3 assessment are provided in Table 6.4.

Community Councils Forum

6.2.16 This forum was set up as part of the DMRB Stage 2 assessment with the purpose of providing regular updates on the proposed Scheme to the community councils along the route and to give members an opportunity to provide a local perspective. Table 6.1 sets out the members of the forum.

Non-Motorised User (NMU) Forum

6.2.17 This forum was set up as part of the A96 Dualling Programme with the purpose of providing regular updates on the emerging design proposals and an opportunity for members to highlight issues they consider relevant and provide advice on appropriate facilities for NMUs. The NMU Forum addressed comments from members on both the proposed Scheme and the wider A96 Dualling Programme. Table 6.2 sets out the members of the forum.

Environmental Steering Group (ESG)

The ESG was set up as part of the proposed Scheme and the wider A96 Dualling Programme to provide a forum for the statutory environmental stakeholders to meet with the relevant members of the project team and receive updates on the proposed Scheme. The members of the group is made up of Transport Scotland and their advisers for each section of the dualling programme, together with Scotlish Natural Heritage (SNH), the Scotlish Environment Protection Agency (SEPA) and Historic Environment Scotland (HES).

Local Authorities and Regional Transport Partnerships Forum

This forum was set up as part of the wider A9 and A96 dualling programmes to provide a means for Transport Scotland to provide regular updates to organisations with a strategic regional transport function and offer a platform for debate on the information presented.

Landowner Consultation

Discussions with potentially affected landowners were also undertaken throughout the DMRB Stage 3 design development process, and where possible requirements were incorporated into the design. This included consideration of aspects such as the alignment of the dual carriageway and land-take, and revised access arrangements to land and properties. Further details of landowner consultation are provided in Chapter 15 (People and Communities: Community and Private Assets).
