| | | FCBC explained the request to extend the working hours for this element of the Works. The works have to be finished before the winter weather arrives and the method of working requires significant length of daily work areas to be available to achieve the required level tolerances. The operation is weather dependent due to the requirement for spreading cement over the working area prior to | |
| | | mixing, so extended hours will only be used when weather permits. The proposal to extend the working hours by two hours per day, one am and one pm, was discussed. The NLG considered that the working methods and plant to be used during the extended hours were unlikely to produce any significant noise issues. FCBC was | |
| | | asked to carry out predictions for the Echline/Springfield area taking in to account the topography of the area in relation to the Works location. | |
| | | The NLG agreed that the extended working hours for this work was acceptable. | |
| | (iv) | PCNV 8 Mod 20 – Network Structures South –Piling | FCBC |
| | | FCBC noted that there is a need to carry out some piling works adjacent to the existing B800 bridge south abutment. Exact details are currently unknown but similar works in the area were undertaken without complaint. FCBC will advise the extent and timing of the works during the weekly telecall once details have been finalised. | |

| | (v) | FCBC will carry out additional monitoring during the installation of the first bridge deck unit. PCNV 29 will be revised if noise levels are found to be higher than those predicted. | FCBC |

| | (vi) | FCBC advised that a complaint had been received from a resident on the South side of the river. The complaint was in relation to a hammering noise heard during the night. FCBC noted that although no exceedances were recorded at the Inchgarvie monitor, the Port Edgar monitor did register some hammering noise on the night in question. Investigation showed that it had been a one off incident. All departments were re-briefed and toolbox talks undertaken. No further complaints have been received. | |
