SOCIETY ROAD – RESURFACING WORKS

We are writing to provide you with notice of planned works on the Forth Replacement Crossing (FRC).

FCBC, the Principal Contractor working on the FRC on behalf of Transport Scotland will, in the next two weeks, be applying the final surfacing works on Society Road between Clufflat and the western extremity of the Forth Replacement Crossing site. This work was to have been carried out in early October but had to be postponed due to logistical difficulties.

Due to the restricted working width available it will not be possible to carry out all the surfacing works and keep traffic flowing at the same time. We therefore plan to carry out the works during the night and divert local traffic, seeking to access/egress Linn Mill, via Hopetoun private roads. Advanced warning traffic signs will forewarn motorists of these plans in the lead up to the temporary diversion being activated. When the diversion is in place and working, motorists will be directed by clear signage **as attached sketch ref 16629 DIV SOCIETY ROAD QUEENSFERRY Phase 1**.

Eastbound Hopetoun traffic will be diverted away from Society Road through roads in Hopetoun. Pedestrians will be able to gain access to and egress from Linn Mill on the newly formed footpath/cycleway within the north verge of Society Road and Emergency Services will be permitted access through our works on Society Road should the need occur.

The diversion will be in place between 8pm and 6am, overnight, on the nights of Monday 11th and Tuesday 12th November 2013. Should we encounter circumstances outwith our control such as adverse weather we will continue with nightshift working through that week until the works are completed.

The plant involved will include, but not be limited to, road pavers, tipper lorries, road rollers, site vans, compressors, generators, temporary floodlighting, hand tools and white lining plant. All material deliveries will be via the site access road between the A904 and Society Road.

We would like to take this opportunity to thank Hopetoun for agreeing to provide their roads as a diversion and we would like to apologise for any inconvenience our activities may cause and also thank you for your patience and consideration to date.

The works as described above are an essential part of the overall Forth Replacement

Crossing project, which is necessary due to concerns over the long term viability of the existing road bridge. The new crossing will maintain a vital link in the east of Scotland road network which is key to the wider Scotlish economy.
