Dear Neighbour,

We are writing to provide you with notice of planned works associated with the Forth Replacement Crossing (FRC), on the B800, between Echline Roundabout and Dundas Golf Club entrance.

The works will comprise all aspects of roadworks including, earthworks, drainage, duct works, utility diversions, kerbing, lighting installation, surfacing and road markings. Plant will include excavators, dumpers, vibrating rollers, breakers, saws, paving machines and lorries.

The first temporary Traffic Management phase will commence on Monday 18th August 2014, when the B800 will be reduced to a single lane, 3.25m wide, in each direction, between Ferrymuir roundabout and ARUP's entrance.

Single way working, utilising temporary traffic lights, will be in operation during the daytime off peak period on Monday 18th August 2014 in order to implement the traffic management scheme. We will be using hot air lances to burn off existing road markings.

<u>"Major works Start Here, 18th Aug for 12 months"</u> signage will be in place at the beginning of next week.

The works will commence on 18th August 2014 and continue through to summer 2015. Various traffic management switches will be notified in advance with multiple phases of work.

The works will be carried out during normal daytime working hours, that is, 8am to 7pm Monday to Friday and 8am to 6pm on Saturdays. Should we require to work outwith these hours we will inform our neighbours accordingly.

In order to mitigate noise impact throughout the process we will be deploying best practical means, including using modern plant. The timings of the proposed works are dependent on many variables throughout the site and may change from those indicated. Also, we may encounter unforeseen ground conditions which may prolong, or alter, operations.

We would like to take this opportunity to apologise for any inconvenience our activities may cause and also to thank you for your patience and consideration to date. The works as described above are an essential part of the overall Forth Replacement Crossing project, which is necessary due to concerns over the long term viability of the existing road bridge. The new crossing will maintain a vital link in the east of Scotland road network which is key to the wider Scottish economy.
