- 1.2 In terms of Clause 17 (Scottish Ministers' Representative) of this Agreement, the Scottish Ministers authorise the Scottish Ministers' Representative to exercise all the powers and rights of the Scottish Ministers under this Agreement other than those conferred by Schedule 11 (Termination Compensation).

# POWERS OF SCOTTISH MINISTERS' SITE REPRESENTATIVE

## 1. **DELEGATION**

- 1.1 Any right or function delegated under this Section 2 of Part 1 of Schedule 13 shall not confer on any party any greater rights than the Scottish Ministers have in accordance with the terms of the Agreement nor does it impose on the Company any further obligations other than those in this Agreement.
- 1.2 In terms of Clause 17 (Scottish Ministers' Representatives) of this Agreement, the Scottish Ministers authorise the Scottish Ministers' Site Representative to exercise all the powers and rights of the Scottish Ministers under this Agreement other than

    - (f) Clause 47 (Voluntary Termination by the Scottish Ministers);
    - (g) Clause 49 (Consequences of Termination);

    - (j) Schedule 11 (Termination Compensation); or
  - 1.2.2 any act which has the effect of amending this Agreement.
- 1.3 For the avoidance of doubt, the Company's Representative shall be entitled to consult anyone he considers appropriate in connection with the discharge of his duties in relation to this Agreement.
