Forth Replacement Crossing - Fife ITS Contract

Notification of Intention to Commence Preliminary Investigation Works

As you may be aware, Transport Scotland is administering the improvement works contracts in relation to the Forth Replacement Crossing (FRC) Project.

Graham Construction has been appointed as the Main Contractor to deliver the initial contract works under the Fife Intelligent Transport System contract (Fife ITS) for the FRC Project. Based on our current programme, I confirm our intention to commence preliminary investigation works on Friday 2nd September 2011 with a scheduled completion on Monday 5th September 2011.

These preliminary investigations are being undertaken in advance of commencement of the FRC - Fife ITS works and will generally involve taking core samples and in-situ testing of the existing M90 southbound carriageway between Halbeath and Admiralty Junction.

The works have been carefully programmed in partnership with key stakeholders including Transport Scotland, Fife Council, FETA and the police, to minimise traffic disruption and impacts on surrounding areas. These works will generally be undertaken during night-time working hours of 20:00 to 06:00

As Community Liaison Officer for the Fife ITS works, and Stakeholder Manager for Graham, I appreciate that certain activities normally associated with construction can result in both perceived and actual increased levels of nuisance and potential impacts to the surrounding environment. Typically, these activities may include heavy mechanical lifting and machine operations, temporary lighting, construction vehicle movement, emergency generators etc.

In this regard, I can assure you that we have adopted best practical means in the development of our design/construction methodology. We shall continue to monitor our activities and potential construction impacts, and take all reasonable steps to minimise disturbance.

We will continue to communicate and engage with you via various media during the FRC – Fife ITS works to ensure that any inconvenience is kept to a minimum.
