The A75 Trunk Road (Castle Kennedy) (50mph Speed Limit) Order 2014

Coming into force - -

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1)(a) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 84(2)(b) of that Act, they have given public notice of their intention to make this Order and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(c).

Citation and commencement

1. This Order may be cited as the A75 Castle Kennedy 50mph Speed Limit Order 2014 and comes into force on

Speed restriction

2. No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road specified in the Schedule to this Order.

Exemption

3. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(d) when used in accordance with regulation 3(5) of those Regulations.

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A75 Gretna to Stranraer trunk road at Castle Kennedy from a point (at Ordnance Map coordinates 210418,560109) 279 metres or thereby west of the point where it meets the extended centreline of Aird Crescent to a point (at Ordnance Map coordinates 211150,559585) 621 metres or thereby east of the point where it meets the extended centreline of Aird Crescent, a distance of 900 metres or thereby.

PRESS NOTICE

THE A75 TRUNK ROAD (CASTLE KENNEDY) (50 MPH SPEED LIMIT) ORDER 2014

THE SCOTTISH MINISTERS give notice that they propose to make the above Order under section 84(1)(a) of the Road Traffic Regulation Act 1984.

This will have the effect of imposing a 50mph speed limit on that length of the A75 Gretna to Stranraer trunk road at Castle Kennedy from a point 279 metres or thereby west of the centreline of Aird Crescent to a point 621 metres or thereby east of the centreline with Aird Crescent, a distance of 900 metres or thereby.

Full details of the proposal are contained in the Order which, together with a plan showing the length of road involved, and a statement of the Scottish Ministers' reasons for proposing to make the Order, may be examined free of charge during normal business hours from 18th December 2014 until 22nd January 2015 at Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF; and the Council Offices, Ashwood House, Sun Street, Stranraer DG9 7JJ.

Any person wishing to object to the proposed Order should send details of the grounds for objection in writing to the Director of Trunk Road and Bus Operations, c/o Mark Paterson, Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF quoting reference A75/SW/SM by 22nd January 2015.

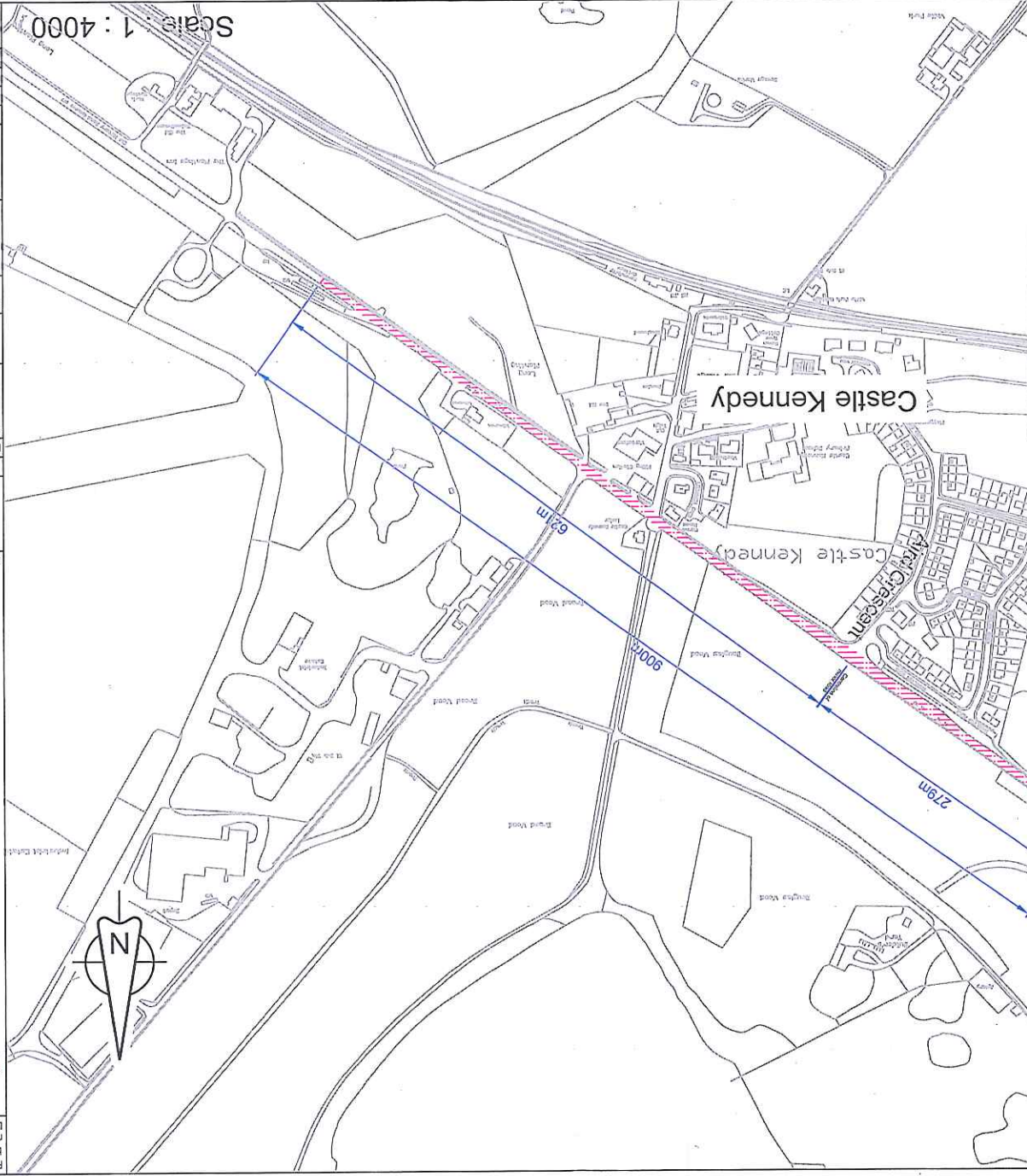
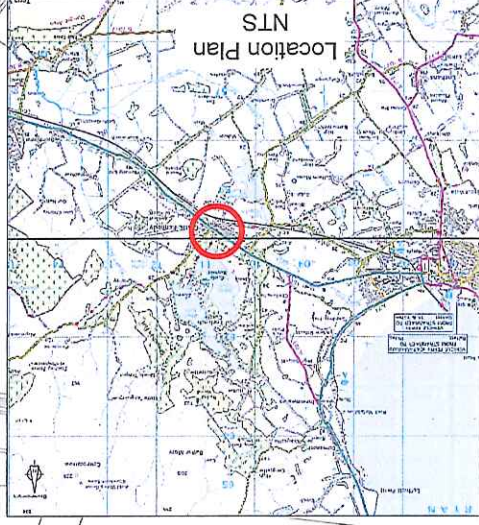

Statement of The Scottish Ministers' Reasons for Applying a Maximum Speed Limit of 50mph on the Section of the A75 at Castle Kennedy.

Following completion of the Speed Limit Review, Scottish Ministers are satisfied that a 50mph Speed Limit be imposed on the A75 Trunk Road at Castle Kennedy to improve road safety. The 50mph speed limit is consistent with other similar routes and is appropriate to the function and nature of the road.
