The A77 Trunk Road (Maybole) (30mph, 20mph and Part-time 20mph Speed Limit) Order 2014

Made

Coming into force -

The Scottish Ministers make the following Order in exercise of the powers conferred by section 82(2)(a) and (b), 83(1), 84(1)(a) and (c), and 124(1)(d) of and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with sections 83(1) and 84(2)(b) of that Act, they have given public notice of their intention to make this Order and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(c).

Citation and commencement

1. This Order may be cited as the A77 Trunk Road (Maybole) (30mph, 20mph and Part-time 20mph Speed Limit) Order 2014 and comes into force on

Restricted roads

2. The length of road specified in Part 1 of the Schedule to this Order shall cease to be a restricted road.

Speed restrictions

- 3.—(1) No person may drive any motor vehicle:—
 - (a) at a speed exceeding 20 miles per hour on the length of road specified in Part 2 of the Schedule to this Order;
 - (b) at a speed exceeding 30 miles per hour on the lengths of road specified in Part 3 of the Schedule to this Order;
 - (c) on the length specified in Part 4 of the Schedule to this Order; at a speed exceeding 30 miles per hour, or at a speed exceeding 20 miles per hour when that speed limit is

PART 1

1. That length of the M77/A77 Glasgow – Stranraer Trunk Road at Maybole, from a point 252 metres or thereby west of the extended western boundary line of Carrick Academy, eastwards to a point 246 metres or thereby east of the extended southern channel of Kirkmichael Road, a distance of 2.1 kilometres or thereby.

THE SCOTTISH MINISTERS give notice that they propose to make the above speed limit Order under sections 82(2)(a) and (b), 83(1), 84(1)(a) and (c) and 124(1)(d) of and paragraph 27 of Schedule 9 to the Road Traffic Regulation Act 1984.

The effect of the order will be as follows:

The following length of road shall cease to be a restricted road:

That length of the M77/A77 Glasgow – Stranraer Trunk Road at Maybole, from a point 252 metres or thereby west of the extended western boundary line of Carrick Academy, eastwards to a point 246 metres or thereby east of the extended southern channel of Kirkmichael Road, a distance of 2.1 kilometres or thereby.

A 20mph speed limit will apply to the following length of road:

That length of the M77/A77 Glasgow – Stranraer Trunk Road at Maybole, from a point 6 metres or thereby south west of its junction with the extended east kerb line of Welltrees Street, to a point 104 metres or thereby east of its junction with the extended east kerb line of Redbrae, a distance of 792 metres or thereby.

A 30mph speed limit will apply to the following lengths or road:

That length of the M77/A77 Glasgow – Stranraer Trunk Road at Maybole, from a point 268 metres or thereby south west of its junction with the extended centre line of Crossraguel View, to a point 112 metres or thereby south west of its junction with the extended centre line of Crossraguel View, a distance of 156 metres or thereby.

That length of the M77/A77 Glasgow – Stranraer Trunk Road at Maybole, from a point 160 metres or thereby east of its junction with the extended centre line of Crossraguel View, to a point 6 metres or thereby south west of its junction with the extended east kerb line of Welltrees Street, a distance of 589 metres or thereby.

That length of the M77/A77 Glasgow – Stranraer Trunk Road at Maybole, from a point 104 metres or thereby east of its junction with the extended east kerb line of Redbrae, to a point 103 metres or thereby north east of its junction with the extended centre line of Lover's Lane, a distance of 313 metres or thereby.

A part - time 20mph speed limit will apply to the following length of road:

That length of the M77/A77 Glasgow – Stranraer Trunk Road at Maybole, from a point 112 metres or thereby south west of its junction with the extended centre line of Crossraguel View, to a point 160 metres or thereby east of its junction with the extended centre line of Crossraguel View, a distance of 272 metres or thereby.

The A77 Trunk Road (Maybole) (Restricted Road) Order 2005 and the A77 Trunk Road (Maybole) (30mph Speed Limit) Variation and Maybole Schools (part time 20mph Speed Limit) Order 2007 will be revoked

The A77 Trunk Road (Maybole) (30mph, 20mph and Part Time 20mph Speed Limit) Order 2014.

Statement of Reasons

The Scottish Ministers aim to promote the safe and efficient use of the roads they are responsible for. Where these pass through towns and villages, there are frequently competing pressures between their strategic purpose, and community interests relating to safety and amenity.

In consideration of these competing interests, Scottish Ministers have identified a number of sites as suitable for a pilot 20 miles per hour speed limit. It is intended that this will support road safety generally, and the safety of vulnerable road users in particular. These sites were chosen with reference to a number of evidence led selection criteria. At each of these pilot sites it is considered that road safety could be further improved by a locally reduced speed limit.

Maybole has been selected as an appropriate pilot site following a review of the evidence, including accident statistics and the carrying out of a speed survey. It is proposed that this Order will impose a full time 20mph speed limit on a length of road through central Maybole measuring 792 metres. No other changes are proposed to the current 30mph limits to the north and south of the proposed 20mph, or the part-time 20mph limit at Carrick Academy, and this Order reinstates those limits.

The pilot is proposed to run for three years and Transport Scotland will be reviewing the effectiveness of the scheme throughout this period.

3. At 23.59 hours on 24th July 2005 the Trunk Roads (Restricted Roads) (Maybole) Order 1977(a) is revoked.

Commencement of New Restricted Road

4. At 00.01 hours on 25th July 2005 the length of road specified in the Schedule to this Order is directed to become a restricted road for the purposes of section 81 of the Road Traffic Regulation Act which imposes a speed limit of 30mph on a restricted road.

- (5) After the Schedule to the Order insert the Schedule to this Order.
