ROAD TRAFFIC

The A9 Trunk Road (Munlochy Junction) (Temporary Prohibition of Specified Turns) Order 2014

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act $1984(\mathbf{a})$ and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A9 Trunk Road (Munlochy Junction) (Temporary Prohibition of Specified Turns) Order 2014, comes into force on 24th August 2014 and ceases to have on 6th September 2014.

Prohibition of specified turns

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the Schedule when such a prohibition is identified as applying to that length of road, or a part or part of that length or road, by means of the traffic signs prescribed in Diagrams 612 and 613 of the Traffic Signs Regulations 2002(**b**).

Exemptions

3. No prohibition imposed by this Order applies to—

- (a) vehicles being used in an emergency for fire brigade, coastguard, ambulance or police purposes; or
- (b) a vehicle while being used for carrying out the works.

SCHEDULE

Article 2

PART 1

SPECIFIED LENGTH OF ROAD

That length of the M9/A9 Edinburgh – Stirling – Thurso Trunk Road from the Artafallie junction to the B9161 Munlochy junction, a distance of 0.7km or thereby.

PART 2

SPECIFIED TURNS

1. All left turns from the southbound M9/A9 Edinburgh – Stirling – Thurso Trunk Road to the B9161 Munlochy Junction.

2. All right turns from the northbound M9/A9 Edinburgh – Stirling – Thurso Trunk Road to the B9161 Munlochy Junction.

3. All left turns from the B9161 Munlochy Junction to the southbound M9/A9 Edinburgh – Stirling – Thurso Trunk Road.

4. All right turns from the B9161 Munlochy Junction to the northbound M9/A9 Edinburgh – Stirling – Thurso Trunk Road.

5. All right turns from the southbound M9/A9 Edinburgh – Stirling – Thurso Trunk Road to the Artafallie Junction

6. All right turns from the Artfallie Junction to the southbound M9/A9 Edinburgh – Stirling – Thurso Trunk Road.

PRESS NOTICE

THE A9 TRUNK ROAD (MUNLOCHY JUNCTION) (TEMPORARY PROHIBITION OF SPECIFIED TURNS) ORDER 2014

THE SCOTTISH MINISTERS give notice that they have made the above Order temporarily prohibiting traffic on that length of the M9/A9 Edinburgh – Stirling – Thurso Trunk Road from the Artafallie junction to the B9161 Munlochy junction, a distance of 0.7km or thereby

1. All left turns from the southbound M9/A9 Edinburgh – Stirling – Thurso Trunk Road to the B9161 Munlochy Junction.

2. All right turns from the northbound M9/A9 Edinburgh – Stirling – Thurso Trunk Road to the B9161 Munlochy Junction.

3. All left turns from the B9161 Munlochy Junction to the southbound M9/A9 Edinburgh – Stirling – Thurso Trunk Road.

4. All right turns from the B9161 Munlochy Junction to the northbound M9/A9 Edinburgh – Stirling – Thurso Trunk Road.

5. All right turns from the southbound M9/A9 Edinburgh – Stirling – Thurso Trunk Road to the Artafallie Junction

The Order, which is required because works are being or are proposed to be executed on or near the said length of road to allow resurfacing to take place, will be in operation from 24 August 2014 until 6 September 2014, but will only have effect in relation to such lengths of road as are indicated by the appropriate traffic signs.
