# ROAD TRAFFIC

The A68 Trunk Road (Edinburgh Road, Jedburgh) (Temporary Prohibition on Waiting and 30mph Speed Limit) Order 2014

Made -

9th June 2014

Coming into force -

21st June 2014

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act, they are satisfied that the traffic on the lengths of road specified in the Schedule should be restricted or prohibited because of the likelihood of danger to the public, which is not attributable to works.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

#### Citation, commencement and cessation

1. This Order may be cited as the A68 Trunk Road (Edinburgh Road, Jedburgh) (Temporary Prohibition on Waiting and 30mph Speed Limit) Order 2014, comes into force on 21st June 2014 and ceases to have effect on 22nd June 2014

### Prohibition on waiting

2. No person may use, or permit the use of, any vehicle to wait on the length of road, or a part or parts of the length of road, specified in Part 1 of the Schedule when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of one or more of the traffic signs prescribed in Diagrams 636 of the Traffic Signs Regulations 2002(b).

#### Speed restriction

3. No person may use, or permit the use of, any vehicle on the length of road, or part or parts of the length of roads, specified in Part 2 of the Schedule to this Order at a speed exceeding 30 miles per hour when a restriction is identified as applying to that length of road, or part or parts of that

length of road, by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002(a).

## **Exemptions**

**4.** No prohibition imposed by this Order applies to a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes.

# SPECIFIED LENGTH OF ROAD

# PART 1

That length of the A68 Edinburgh - Carter Bar Trunk Road, Edinburgh Road, Jedburgh, from the junction of the A68 and the entrance to the Bankend North Industrial Estate, northwards, to a point 753 metres north of that point, at the junction of the A68 and the entrance to the sewage works, a total distance of 753 metres or thereby.

## PART 2

That length of the A68 Edinburgh - Carter Bar Trunk Road, Edinburgh Road, Jedburgh, from a point 117 metres north of the junction of the A68 and the entrance to the Bankend North Industrial Estate, northwards, to a point 636 metres north of that point, at the junction of the A68 and the entrance to the sewage works, a total distance of 636 metres or thereby.

#### PRESS NOTICE

THE A68 TRUNK ROAD (EDINBURGH ROAD, JEDBURGH) (TEMPORARY PROHIBITION ON WAITING AND 30MPH SPEED LIMIT) ORDER 2014

The Scottish Ministers give notice that they have made the above Order, under section 2(1) and (2), 4(1) and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984, the effect of the Order is to:

- 1. Temporarily prohibit waiting by traffic on that length of the A68 Edinburgh Carter Bar Trunk Road, Edinburgh Road, Jedburgh, from the junction of the A68 and the entrance to the Bankend North Industrial Estate, northwards, to a point 753 metres north of that point, at the junction of the A68 and the entrance to the sewage works, a total distance of 753 metres or thereby.
- 2. The Order also restricts the speed of vehicles to 30mph travelling on that length of the A68 Edinburgh Carter Bar Trunk Road, Edinburgh Road, Jedburgh, from a point 117 metres north of the junction of the A68 and the entrance to the Bankend North Industrial Estate, northwards, to a point 636 metres north of that point, at the junction of the A68 and the entrance to the sewage works, a total distance of 636 metres or thereby.

The Order, which is required to allow safe and unobstructed access of the A68 adjacent to Riverside Park, will be in force from 21<sup>st</sup> June 2014 until 22<sup>nd</sup> June 2014 but will only have effect in relation to such length(s) of road as are indicated by the appropriate traffic signs.

The Order does not apply to vehicles being used in an emergency for fire brigade, coastguard, ambulance or police purposes or to acts done with the permission or upon the direction of a police constable in uniform.

Alternative routes for traffic in relation to the lengths of road affected by the Order during the prohibition will be as signposted. Detailed descriptions can be obtained at BEAR Scotland, Bilston Glen Industrial Estate, 6A Dryden Road, Loanhead, Midlothian, EH20 9TY.
