# The A77 Trunk Road (Girvan) (30mph Speed Limit) Order 2015

 Made
 20th May 2015

 Coming into force
 28th May 2015

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1)(a) and 124(1)(d) of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section  $84(2)(\mathbf{b})$  of that Act, they have given public notice of their intention to make this Order and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987( $\mathbf{c}$ ).

#### Citation and commencement

**1.** This Order may be cited as the A77 Trunk Road (Girvan) (30mph Speed Limit) Order 2015 and comes into force on 28th May 2015.

### **Speed restriction**

**2.** No person may drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in the Schedule to this Order.

#### Revocation

**3.** The A77 Trunk Road (Girvan) (Restricted Roads) Order 2011(**d**) is revoked.

### **SCHEDULE**

Article 2

### SPECIFIED LENGTHS OF ROAD

- **1.** That length of the M77/A77 Glasgow Stranraer Trunk Road at Girvan, from a point 48 metres or thereby west of Shallochpark Roundabout to a point on Glendoune Street at the extended north kerbline of Cauldshore, a distance of 545 metres or thereby.
- **2.** That length of the M77/A77 Glasgow Stranraer Trunk Road at Girvan, from a point on Glendoune Street at the extended north kerbline of Cauldshore to a point on Dalrymple Street at the extended south kerbline of Knockcushan Street, a distance of 1.178 kilometres or thereby.
- **3.** That length of the M77/A77 Glasgow Stranraer Trunk Road at Girvan, from a point on Glendoune Street at the extended north kerbline of Cauldshore to a point on Henrietta Street at the extended south kerbline of Knockcushan Street, a distance of 1.161 kilometres or thereby.
- **4.** That length of the M77/A77 Glasgow Stranraer Trunk Road at Girvan, from a point on Knockcushan Street at the extended west kerbline of Henrietta Street to a point at the extended east kerbline of Dalrymple Street, a distance of 205 metres or thereby.
- **5.** That length of the M77/A77 Glasgow Stranraer Trunk Road at Girvan, from a point 8 metres or thereby south of the extended north kerbline of Knockcushan Street at Bridge Street to a point 65 metres or thereby north of Bridgemill Roundabout, a distance of 1.024 kilometres or thereby.
