ROAD TRAFFIC

The A82 Trunk Road (Crianlarich Bypass) (Temporary Speed Restriction) Order 2014

Made - - - - 4th August 2014

Coming into force - - 11th August 2014

The Scottish Ministers make the following Order in exercise of the powers conferred by section 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the Schedule should be prohibited or restricted because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

In accordance with section 14(1A) of that Act, they have consulted with the affected National Park(b).

Citation, commencement and cessation

1. This Order may be cited as the A82 Trunk Road (Crianlarich Bypass) (Temporary Speed Restriction) Order 2014, comes into force on 11th August 2014 and ceases to have effect on 1st April 2015.

Speed restriction

- 2.—(1) No person may drive any vehicle on the length of road, or a part or parts of the length of road, specified in the Schedule to this Order at a speed exceeding 30 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002.
- (2) When convoy working is in operation and indicated by one or more of the traffic signs prescribed in Diagrams 7011, 7025, 7026, 7027, 7028 and 7029 of the Traffic Signs Regulations

2002, no person may drive any vehicle on the length of road, or a part or parts of the length of road, specified in the Schedule to this Order at a speed exceeding 10 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002.

Exemptions

3. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

SCHEDULE

Article 2

That length of the A82 Dalnottar- Inverness Trunk Road, at Crianlarich, from a point 60 metres or thereby south of its junction with the A84/A85 Stirling-Crianlarich Trunk Road at Crianlarich, to a point 1670 metres or thereby south of that point, a total distance of 1670 metres or thereby.

PRESS NOTICE

THE A82 TRUNK ROAD (CRIANLARICH BYPASS) (TEMPORARY SPEED RESTRICTION) ORDER 2014

THE SCOTTISH MINISTERS give notice that they have made the above Order temporarily restricting the speed of vehicles to 30 mph and 10 mph when there is convoy working on the following length of road:

That length of the A82 Dalnottar- Inverness Trunk Road, at Crianlarich, from a point 60 metres or thereby south of its junction with the A84/A85 Stirling-Crianlarich Trunk Road at Crianlarich, to a point 1670 metres or thereby south of that point, a total distance of 1670 metres or thereby.

This Order, which is required because works are being or are proposed to be executed on or near the said length of road to allow construction work to take place, will be in operation from 11th August 2014 until 1st April 2015 and will only have effect in relation to such length of the road as is indicated by the appropriate traffic signs.

Alternative routes for the traffic during the prohibition will be signposted.
