ROAD TRAFFIC

The A82 Trunk Road (Pulpit Rock Improvement) (Temporary Prohibition of Traffic and Overtaking and Speed Restriction) Order 2014

Made - - - - *18th June 2014*
Coming into force - - *2nd July 2014*

The Scottish Ministers make the following Order in exercise of the powers conferred by section 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the Schedule should be prohibited or restricted because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

In accordance with section 14(1A) of that Act, they have consulted with the affected National Park(b).

Citation, commencement and cessation

1. This Order may be cited as the A82 Trunk Road (Pulpit Rock Improvement) (Temporary Prohibition of Traffic and Overtaking and Speed Restriction) Order 2014, comes into force on 2nd July 2014 and ceases to have effect on 9th November 2014.

Prohibition on use of road

2. No person may use, or permit the use of, any vehicle on the length of road, or part or parts of that length of road, specified in Part 1 of the Schedule to this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of

one or more of the traffic signs prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(a).

Prohibition on overtaking

3.—(1) No person may use, or permit the use of, any vehicle in such a way that it overtakes any other moving vehicle on the lengths of road, or a part or parts of those lengths of road, specified in Parts 1 and 2 of the Schedule when a prohibition is identified as applying to those lengths of road, or a part or parts of those lengths of road, by means of a traffic sign prescribed in Diagram 632 of the Traffic Signs Regulations 2002.

(2) "Other moving vehicle" does not include a cycle, motor cycle, tricycle or any other vehicle not being a motor vehicle in accordance with section 140 of the Road Traffic Regulation Act 1984(b).

Speed restriction

4. No person may drive any vehicle on the lengths of road, or a part or parts of those lengths of road, specified in Parts 1 and 2 of the Schedule, at a speed exceeding 30mph when such a restriction is identified as applying to those lengths of road, or a part or parts of those lengths of road, by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002.

Exemptions

5. No prohibition imposed by this Order applies to vehicles being used for carrying out the works.

6. No prohibition imposed by Article 3 applies to vehicles being used in an emergency for fire brigade, ambulance, police or coastguard purposes.

7. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(c) when used in accordance with regulation 3(5) of those Regulations.

SCHEDULE

Articles 2, 3 and 4

PART 1

That length of the A82 Dalnottar – Inverness Trunk Road from a point 120 metres or thereby northwest of The Pulpit Rock Monument to a point 524 metres or thereby southeast of The Pulpit Rock Monument, a distance of 644 metres or thereby.

PART 2

That length of the southbound A82 Dalnottar – Inverness Trunk Road from a point 103 metres or thereby northwest of the access to Stuckendroin Farm, to a point 120 metres or thereby northwest of The Pulpit Rock Monument, in a southwards direction of travel, a distance of 1000 metres or thereby.

That length of the northbound A82 Dalnottar-Inverness Trunk Road from a point 120 metres northwest of The Pulpit Rock Monument to a point 245 metres southeast of the access to Stuckendroin Farm, in a northwards direction of travel, a distance of 650 metres.

THE A82 TRUNK ROAD (PULPIT ROCK IMPROVEMENT) (TEMPORARY PROHIBITION OF TRAFFIC AND OVERTAKING AND SPEED RESTRICTION) ORDER 2014

THE SCOTTISH MINISTERS give notice that they have made the above Order under section 14(1)(a) of the Road Traffic Regulation Act 1984. The effect of the Order will be to continue in effect the temporary prohibition on the use of the road, the prohibition on overtaking and the speed restriction of 30mph on the length of road described in Part 1 of the schedule to the Order. It will additionally extend the prohibition on overtaking and the speed restriction to lengths of road in Part 2 of the schedule to the Order. Those lengths of road are as follows:

Part 1

That length of the A82 Dalnottar – Inverness Trunk Road from a point 120 metres or thereby northwest of The Pulpit Rock Monument to a point 524 metres or thereby southeast of The Pulpit Rock Monument, a distance of 644 metres or thereby.

Part 2

That length of the southbound A82 Dalnottar – Inverness Trunk Road from a point 103 metres or thereby northwest of the access to Stuckendroin Farm, to a point 120 metres or thereby northwest of The Pulpit Rock Monument, in a southwards direction of travel, a distance of 1000 metres or thereby.

That length of the northbound A82 Dalnottar-Inverness Trunk Road from a point 120 metres northwest of The Pulpit Rock Monument to a point 245 metres southeast of the access to Stuckendroin Farm, in a northwards direction of travel, a distance of 650 metres.

This Order continues in effect the prohibitions over the length of road in Part 1 of the schedule to the Order which are currently in force in the A82 Trunk Road (Pulpit Rock Improvement) (Temporary Prohibition of Traffic and Overtaking and Speed Restriction) Order 2013 (SSI 2013/138). That Order ceases to have effect on 1st July 2014.

This Order, which is required because works are being or are proposed to be executed on or near the said length of road to allow construction work to take place, and will allow the current works to continue, will be in operation from 2nd July 2014 until 9th November 2014 and will only have effect in relation to such length of the road as is indicated by the appropriate traffic signs. The Order does not apply to vehicles while being used in connection with the works.

Alternative routes for the traffic during the prohibition will be signposted.
