# The A83 Trunk Road (Furnace to Cumlodden) (50mph Speed Limit) Order 2015

Made - - - - - Coming into force - -

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1)(a) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section  $84(2)(\mathbf{b})$  of that Act, they have given public notice of their intention to make this Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987( $\mathbf{c}$ ).

#### Citation and commencement

**1.** This Order may be cited as the A83 Trunk Road (Furnace to Cumlodden) (50mph Speed Limit) Order 2015 and comes into force on [x].

#### **Speed restriction**

**2.** No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road specified in the Schedule to this Order.



THE SCOTTISH MINISTERS hereby give notice that they propose to make the above Order under section 84(1)(a) of the Road Traffic Regulation Act 1984 which will have the effect of imposing a 50 mph speed limit on that length of the A83 Tarbet – Lochgilphead – Campbeltown Trunk Road from a point (at Ordnance Map coordinates 201241, 699442), 1.242 kilometres or thereby south west of the extended centre line of the junction with the C36 Furnace Side Road to a point (at Ordnance Map coordinates 20051, 698468), 130 metres or thereby south west of the point where it meets the extended western gable wall of Number 1 Cumlodden Cottages a distance of 1.558 kilometres or thereby.

# Statement of The Scottish Ministers' Reasons for Applying a Maximum Speed Limit of 50mph on the Section of the A83 Furnace to Cumlodden Trunk Road

Following completion of the Speed Limit Review, Scottish Ministers are satisfied that a 50 mph Speed Limit be imposed on the A83 Trunk Road from Furnace to Cumlodden to improve road safety.
