PRESS NOTICE

THE A83 TRUNK ROAD (TARBERT) (TEMPORARY PROHIBITION ON USE OF ROAD) ORDER 2015.

THE SCOTTISH MINISTERS give notice that they have made the above Order under sections 2(1), 2(2), 4(1) and 16A of the Road Traffic Regulation Act 1984, temporarily prohibiting traffic on that length of the A83 Tarbet – Lochgilphead – Campbeltown Trunk Road from the junction with the car park at the Tarbert Health Centre, Campbeltown Road to the junction with Harbour Street, a distance of 180 metres or thereby.

The Order, which is required to facilitate the Loch Fyne Viking Festival 2015 and to enable the hand hauling of a Viking ship to the jetty in Harbour Street, will be in operation from 1400 hours until 1500 hours on 27th June 2015. The Order does not apply to vehicles whilst being used in an emergency for fire brigade, coastguard, ambulance or police purposes.

ALTERNATIVE ROUTES

An alternative route for traffic during the prohibition is not required.

ROAD TRAFFIC

The A83 Trunk Road (Tarbert to Campbeltown) (Temporary Prohibition On Use of Road) Order 2015

 Made
 11th June 2015

 Coming into force
 27th June 2015

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 16A of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 16A(2) of that Act, they are satisfied that the traffic on the length of road specified in the Schedule should be restricted or prohibited for the purpose of facilitating the holding of a relevant event and enabling members of the public to watch that relevant event.

In accordance with section 16A(3) of that Act, they are satisfied that it is not reasonably practicable for the event to be held otherwise than on a road.

In accordance with section 16A(8) of that Act, they have had regard to the safety and convenience of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A83 Trunk Road (Tarbert to Campbeltown) (Temporary Prohibition On Use of Road) Order 2015, comes into force on 27th June 2015 and ceases to have effect on 28th June 2015.

Prohibition on use of vehicles

2. No person may use or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the Schedule to this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of traffic signs prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(**b**).

Exemptions

- 3. No prohibition imposed by this Order applies to—
 - (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
 - (b) a vehicle being used for facilitating the holding of the relevant event.

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A83 Tarbert – Lochgilphead – Campbeltown Trunk Road known as Campbeltown Road Tarbert from the junction with the carpark at Tarbert Health Centre Campbeltown Road to the junction with Harbour Street, a distance of 180 metres or thereby.
