ROAD TRAFFIC

The A85 Trunk Road (Dunollie Road) (Temporary Prohibition on Use of Road) Order 2014

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act $1984(\mathbf{a})$ and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A85 Trunk Road (Dunollie Road) (Temporary Prohibition on Use of Road) Order 2014, comes into force on 14th May 2014 and ceases to have effect on 23rd May 2014.

Prohibition on use of road

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the Schedule to this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of the traffic signs prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(**b**).

Exemptions

3. No prohibition imposed by this Order applies to—

(a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A85 Tyndrum – Oban Trunk Road from its junction with the roundabout opposite the Corran Halls at the northern end of Dunollie Road, Oban southwards to its junction with George Street, Oban, a distance of 210 metres or thereby.

PRESS NOTICE

THE A85 TRUNK ROAD (DUNOLLIE ROAD, OBAN) (TEMPORARY PROHIBITION ON USE OF ROAD) ORDER 2014

THE SCOTTISH MINISTERS give notice that they have made the above Order temporarily prohibiting traffic on that length of the A85 Tyndrum – Oban Trunk Road from its junction with the roundabout opposite the Corran Halls at the northern end of Dunollie Road, Oban southwards to its junction with George Street, Oban, a distance of 210 metres or thereby.

The Order, which is required to allow for resurfacing works, will be in operation from 14th May 2014 until 23rd May 2014 and will only have effect in relation to such length of road as is indicated by the appropriate traffic signs. The Order does not apply to vehicles while being used in connection with the works or vehicles being used in an emergency for fire brigade, coastguard, ambulance or police purposes or to acts done with the permission or upon the direction of a police constable in uniform.

The alternative routes for traffic during the prohibition will be signposted. Detailed descriptions can also be obtained at BEAR Scotland, BEAR House, Inveralmond Road, Inveralmond Industrial Estate, Perth, PH1 3TW.
