ROAD TRAFFIC

The A85 Trunk Road (Lochearnhead to Lix Toll) (50 mph Speed Limit) Order 2014

The Scottish Ministers make the following Order in exercise of the powers conferred by section 84(1)(a) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 84(2)(b) of that Act, they have given public notice of their intention to make this Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(c).

Citation and commencement

1. This Order may be cited as the A85 Trunk Road (Lochearnhead to Lix Toll) (50mph Speed Limit) Order 2014 and comes into force on

Speed restriction

2. No person may drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road specified in the Schedule to this Order.

Exemption

3. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(d) when used in accordance with regulation 3(5) of those Regulations.

SPECIFIED LENGTH OF ROAD

That length of the A84/A85 Stirling - Crianlarich Trunk Road from a point (at Ordnance Map coordinates 258744,724059) 293 metres or thereby north of the extended centre line of its junction with the A85 Perth - Lochearnhead Trunk Road, north-westerly, to a point (at Ordnance Map coordinates 254618,730096) 152 metres or thereby west of the extended centre line of its junction with the A827 road, a distance of 7.856 kilometres or thereby.

THE SCOTTISH MINISTERS hereby give notice that they propose to make the above Order under section 84(1)(a) of the Road Traffic Regulation Act 1984 which will have the effect of imposing a 50 mph speed limit on that length of the A84/A85 Stirling - Crianlarich Trunk Road from a point 293 metres or thereby north of the extended centre line of its junction with the A85 Perth - Lochearnhead Trunk Road, north-westerly, to a point 152 metres or thereby west of the extended centre line of its junction with the A827 road, a distance of 7.856 kilometres or thereby.

Following completion of the Speed Limit Review, Scottish Ministers are satisfied that a 50mph Speed Limit be imposed on the A85 Stirling to Crianlarich Trunk Road from Lochearnhead to Lix Toll to improve road safety.
