ROAD TRAFFIC

The A96 Trunk Road (Auchmill Road) (Temporary Prohibition of Specified Turns) Order 2015

Made - - - - - *2nd February 2015*
Coming into force - - - - - *16th February 2015*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A96 Trunk Road (Auchmill Road) (Temporary Prohibition of Specified Turns) Order 2015, comes into force on 16th February 2015 and ceases to have effect on 27th February 2015.

Prohibition of specified turns

2. No person may use, or permit the use of, any vehicle on the length of road specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the Schedule when a prohibition is identified as applying to that length of road by means of the traffic signs prescribed in Diagrams 612 and 613 of the Traffic Signs Regulations 2002(b).

Exemptions

3. No prohibition imposed by this Order applies to—

(a) a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes; or

(a) 1984 c.27; section 2(1) and (2) were amended by the New Road and Street Works Act 1991 (c.22) ("the 1991 Act"), paragraph 18 and section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), Schedule 1. The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (inserted by the 1991 Act, Schedule 8, paragraph 70 and amended by S.I. 2001/1400) as read with section 151(1) of the Roads (Scotland) Act 1984 (c.54). The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).
(b) Part 1 of S.I. 2002/3113.

(b) a vehicle being used for carrying out the works.

SCHEDULE

Article 2

PART 1

SPECIFIED LENGTH OF ROAD

That length of the A96 Aberdeen - Inverness Trunk Road at its junction with Auchmill Road, Aberdeen at the property known as 426 Auchmill Road.

PART 2

SPECIFIED TURNS

Left turns from the westbound carriageway of the A96 Aberdeen - Inverness Trunk Road into the crescent forming Auchmill Road, Aberdeen.

PRESS NOTICE

THE A96 TRUNK ROAD (AUCHMILL ROAD JUNCTION) (TEMPORARY PROHIBITION OF SPECIFIED TURNS) ORDER 2015

THE SCOTTISH MINISTERS hereby give notice that they have made the above Order temporarily prohibiting traffic that length of the A96 Aberdeen - Inverness Trunk Road at its junction with Auchmill Road, Aberdeen at the property known as 426 Auchmill Road, from making any of the following turns:


Left turns from the westbound carriageway of the A96 Aberdeen - Inverness Trunk Road into the crescent forming Auchmill Road, Aberdeen.

The Order, which is required because works are being or are proposed to be executed on or near the said road junction to allow for a borehole survey to take place, will be in operation from 16th February 2015 until midnight on the 26th February 2015 but will only have effect in relation to such lengths of road as are indicated by the appropriate traffic signs. The Order does not apply to works vehicles or vehicles being used in an emergency for fire brigade, coastguard, ambulance or police purposes or to acts done with the permission or upon the direction of a police constable in uniform.

Alternative routes for traffic in relation to the length of road affected by the Order during the prohibition will be as signposted. Detailed descriptions can be obtained at BEAR Scotland Ltd, Bear House, Inveralmond Road, Inveralmond Industrial Estate, Perth PH1 3TW
