ROAD TRAFFIC

**The M9/A9 Trunk Road (Aberuthven to Findo Gask)
(Temporary Prohibition of Specified Turns) Order 2014**

Made - - - - - *21st March 2014*

Coming into force - - - - - *31st March 2014*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the M9/A9 Trunk Road (Aberuthven to Findo Gask) (Temporary Prohibition of Specified Turns) Order 2014, comes into force on 31st March 2014 and ceases to have effect on 31st May 2014.

Prohibition of specified turns

2. No person may use, or permit the use of, any vehicle on the length of road specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the Schedule when a prohibition is identified as applying to that length of road by means of the traffic signs prescribed in Diagrams 612 and 613 of the Traffic Signs Regulations 2002(b).

The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (inserted by the New Roads and Street Works Act 1991, Schedule 8, paragraph 70 and amended by S.I. 2001/1400) as read with section 151(1) of the Roads (Scotland) Act 1984 (c.54). The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes;
- (b) a vehicle being used for carrying out the works; or
- (c) an agricultural tractor making a turn specified in paragraph 15 or 16 of Part 2 of the Schedule while being used in connection with the business of North Strathy Farm, Aberuthven.

SCHEDULE

Article 2

PART 1

SPECIFIED LENGTH OF ROAD

That length of the M9/A9 Edinburgh-Stirling-Thurso Trunk Road from a point 1 kilometre or thereby south west of its junction with the A824 at Aberuthven, north-eastwards to a point 500 metres or thereby north east of its junction with the ZU50 Findo Gask Road, a distance of 4 kilometres or thereby.

PART 2

SPECIFIED TURNS

1. All right turns from the ZU24 Whitemoss Road to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
2. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the ZU24 Whitemoss Road.
3. All right turns from the A824 Main Road, Aberuthven to the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
4. All right turns from the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the A824 Main Road, Aberuthven.
5. All left turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the A824 Main Road, Aberuthven.
6. All left turns from the A824 Main Road, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
7. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to Maidenplain, Aberuthven.
8. All right turns from Maidenplain, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
9. All right turns from the field access located on the southbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
10. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the field access located on the southbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven.
11. All right turns from the field access located on the northbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven to the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
12. All right turns from the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the field access located on the northbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven.

13. All left turns from the field access located on the northbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.

14. All left turns from the northbound M9/A9 Edinburgh – Stirling - Thurso Trunk Road to the field access located on the northbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven.

15. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to North Strathy Farm, Aberuthven

16. All right turns from North Strathy Farm, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.

17. All right turns from the access road from Millands, Aberuthven to the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.

18. All left turns from the access road from Millands, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.

19. All left turns from northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the access road to Millands, Aberuthven.

20. All right turns from the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the access road to Millands, Aberuthven.

21. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the field access located on the southbound verge about 310 metres or thereby north of the access road to North Strathy Farm, Aberuthven.

22. All right turns from the field access located on the southbound verge about 310 metres or thereby north of the access road to North Strathy Farm, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.

23. All right turns from the B9141 Dunning Road to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.

24. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the B9141 Dunning Road.

25. All right turns from the ZU50 Findo Gask Road to the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.

26. All right turns from the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the ZU50 Findo Gask Road.

THE M9/A9 TRUNK ROAD (ABERUTHVEN TO FINDO GASK) (TEMPORARY PROHIBITION OF SPECIFIED TURNS) ORDER 2014

THE SCOTTISH MINISTERS give notice that they have made the above Order temporarily prohibiting traffic on that length of the M9/A9 Edinburgh-Stirling-Thurso Trunk Road from a point 1 kilometre or thereby south west of its junction with the A824 at Aberuthven north-eastwards to a point 500 metres or thereby north east of its junction with the ZU50 Findo Gask Road, a distance of 4 kilometres or thereby from making any of the following turns:

1. All right turns from the ZU24 Whitemoss Road to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
2. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the ZU24 Whitemoss Road.
3. All right turns from the A824 Main Road, Aberuthven to the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
4. All right turns from the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the A824 Main Road, Aberuthven.
5. All left turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the A824 Main Road, Aberuthven.
6. All left turns from the A824 Main Road, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
7. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to Maidenplain, Aberuthven.
8. All right turns from Maidenplain, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
9. All right turns from the field access located on the southbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
10. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the field access located on the southbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven.
11. All right turns from the field access located on the northbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven to the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
12. All right turns from the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the field access located on the northbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven.
13. All left turns from the field access located on the northbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
14. All left turns from the northbound M9/A9 Edinburgh - Stirling - Thurso Trunk Road to the field access located on the northbound verge about 325 metres or thereby south of the access to North Strathy Farm, Aberuthven.
15. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to North Strathy Farm, Aberuthven
16. All right turns from North Strathy Farm, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
17. All right turns from the access road from Millands, Aberuthven to the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
18. All left turns from the access road from Millands, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.


19. All left turns from northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the access road to Millands, Aberuthven.
20. All right turns from the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the access road to Millands, Aberuthven.
21. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the field access located on the southbound verge about 310 metres or thereby north of the access road to North Strathy Farm, Aberuthven.
22. All right turns from the field access located on the southbound verge about 310 metres or thereby north of the access road to North Strathy Farm, Aberuthven to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
23. All right turns from the B9141 Dunning Road to the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
24. All right turns from the northbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the B9141 Dunning Road.
25. All right turns from the ZU50 Findo Gask Road to the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road.
26. All right turns from the southbound M9/A9 Edinburgh-Stirling-Thurso Trunk Road to the ZU50 Findo Gask Road.

The Order, which is required because works are being or are proposed to be executed on or near the said length of road to allow resurfacing to take place, will be in operation from 31 March 2014 until midnight on 31 May 2014, but will only have effect in relation to such lengths of road as are indicated by the appropriate traffic signs. The Order does not apply vehicles being used in an emergency for fire brigade, coastguard, ambulance or police purposes and the turns specified in numbered paragraphs 15 and 16 above do not apply to agricultural tractors whilst being used in connection with the business of North Strathy Farm, Aberuthven.
