# **ROAD TRAFFIC**

The A92/A972 Trunk Road (B969 Western Avenue to the C49 leading to Star) (Temporary Prohibition of Specified Turns) (No. 2) Order 2014

Made

7th November 2014

Coming into force -

17th November 2014

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

#### Citation, commencement and cessation

1. This Order may be cited as the A92/A972 Trunk Road (B969 Western Avenue to the C49 leading to Star) (Temporary Prohibition of Specified Turns) (No. 2) Order 2014, comes into force on 17th November 2014 and ceases to have effect on 20th December 2014.

#### Prohibition of specified turns

2. No person may use, or permit the use of, any vehicle on the length of road specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the Schedule when a prohibition is identified as applying to that length of road by means of the traffic signs prescribed in Diagrams 612 and 613 of the Traffic Signs Regulations 2002(b).

# Exemptions

- 3. No prohibition imposed by this Order applies to—
  - (a) a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes; or
  - (b) a vehicle being used for carrying out the works.

#### PART 1

#### SPECIFIED LENGTH OF ROAD

That length of the A92/A972 Kirkcaldy - Dundee Trunk Road from a point 160 metres or thereby north of its junction with the B969 Western Avenue, Glenrothes, southwards to a point 300 metres or thereby south of its junction with the C49 to Star, Glenrothes, a distance of 580 metres or thereby.

#### PART 2

#### SPECIFIED TURNS

- 1. All right turns from the southbound A92/A972 Kirkcaldy Dundee Trunk Road to the B969 Western Avenue.
- **2.** All right turns from the B969 Western Avenue to the southbound A92/A972 Kirkcaldy Dundee Trunk Road.
- 3. All right turns from the northbound A92/A972 Kirkcaldy Dundee Trunk Road to the C49 leading to Star.
- **4.** All right turns from the C49 leading from Star to the northbound A92/A972 Kirkcaldy Dundee Trunk Road.
- **5.** All left turns from the southbound A92/A972 Kirkcaldy Dundee Trunk Road to the C49 leading to Star.
- **6.** All left turns from the C49 leading from Star to the southbound A92/A972 Kirkcaldy Dundee Trunk Road.
- 7. All left turns from the northbound A92/A972 Kirkcaldy Dundee Trunk Road to the B969 Western Avenue.
- **8.** All left turns from the B969 Western Avenue to the northbound A92/A972 Kirkcaldy Dundee Trunk Road.

### PRESS NOTICE

# The A92/A972 Trunk Road (B969 Western Avenue to the C49 leading to Star) (Temporary Prohibition of Specified Turns) (No.2) Order 2014

The Scottish Ministers give notice that they have made the above Order temporarily prohibiting traffic on that length of the A92/A972 Kirkcaldy - Dundee Trunk Road from a point 160 metres or thereby north of the junction with Western Avenue, Glenrothes southwards to a point 300 metres or thereby south of the junction with the C49 to Star, Glenrothes, a distance of 580 metres or thereby from making any of the following turns:

- 1. All right turns from the southbound A92/A972 Kirkcaldy Dundee Trunk Road to the B969 Western Avenue.
- 2. All right turns from the B969 Western Avenue to the southbound A92/A972 Kirkcaldy Dundee Trunk Road.
- 3. All right turns from the northbound A92/A972 Kirkcaldy Dundee Trunk Road to the C49 leading to Star.
- 4. All right turns from the C49 leading from Star to the northbound A92/A972 Kirkcaldy Dundee Trunk Road.
- 5. All left turns from the southbound A92/A972 Kirkcaldy Dundee Trunk Road to the C49 leading to Star.
- 6. All left turns from the C49 leading from Star to the southbound A92/A972 Kirkcaldy Dundee Trunk Road.
- 7. All left turns from the northbound A92/A972 Kirkcaldy Dundee Trunk Road to the B969 Western Avenue.
- 8. All left turns from the B969 Western Avenue to the northbound A92/A972 Kirkcaldy Dundee Trunk Road.

The Order, which is required because works are being or are proposed to be executed on or near the said length of road to allow for resurfacing, installation of safety barriers, footway works, cabling, lighting, signing and lining works to take place, will be in operation from 17th November 2014 until 20th December 2014, but will only have effect in relation to such lengths of road as are indicated by the appropriate traffic signs. The Order does not apply to works vehicles or vehicles being used in an emergency for fire brigade, coastgaurd, ambulance or police purposes or to acts done with the permission or upon the direction of a police constable in uniform.
