SCHEME 201[]**

NOTICE IS HEREBY GIVEN, that the Scottish Ministers, propose to make the following Orders:

1. The M8 (Junction 29A at A8 Greenock Road) Special Road Scheme 201[] under sections 7, 8(2) and 10(1) of the Roads (Scotland) Act 1984.
2. The M8 (Junction 29A at A8 Greenock Road) Side Roads Order 201[] under sections 9(1)(c), (d) and (f) and 70(1) of the Roads (Scotland) Act 1984.

The general effect of the Scheme will be to provide a new section of special road on the existing M8/A8 Edinburgh – Greenock Trunk Road.

ENVIRONMENTAL IMPACT ASSESSMENT

DETERMINATION BY THE SCOTTISH MINISTERS

THE SCOTTISH MINISTERS hereby give notice that they have determined that their proposal to improve and construct new lengths of road in relation to the M8/A8 Edinburgh – Greenock Trunk Road in the vicinity of Junction 29A at A8 Greenock Road:-

(a) is not a project which falls within Annex I of Directive 2011/92/EU of the European Parliament and of the Council on the assessment of the effects of certain public and private projects on the environment as amended by Directive 2014/52/EU of the European Parliament and of the Council of 16 April 2014. Directive 2011/92/EU repealed and recast the provisions contained in Council Directive 85/337/EEC as amended by Council Directive 97/11/EC, Directive 2003/35/EC of the European Parliament and Council and Directive 2009/31/EC of the European Parliament and Council;

(b) is a relevant project within the meaning of Sections 20A(9) and 55A(7) of the Roads (Scotland) Act 1984 and falls within Annex II of the said Directive and having regard to the selection criteria contained in Annex III of the said Directive it should be made subject to an environmental impact assessment in accordance with the said Directive, and accordingly the project does require an Environmental Statement.

NOTICE OF ENVIRONMENTAL STATEMENT

THE SCOTTISH MINISTERS, as the relevant roads authority, are considering implementing the following project:-

The M8 (Junction 29A at A8 Greenock Road) Special Road Scheme 201[] in the County of Renfrewshire is a road improvement project.

They intend to make the M8 (Junction 29A at A8 Greenock Road) Special Road Scheme 201[] under sections 7, 8(2) and 10(1) of the Roads (Scotland) Act 1984 and the M8 (Junction 29A at A8 Greenock Road) Side Roads Order 201[] under sections 9(1)(c), (d) and (f) and 70(1) of the Roads (Scotland) Act 1984 to provide a new section of special road on the existing M8/A8 Edinburgh – Greenock Trunk Road.

THE SCOTTISH MINISTERS, give notice that the project is subject to the environmental impact assessment procedure prescribed by sections 20A and 55A of the Roads (Scotland) Act 1984 as amended and Directive 2011/92/EU of the European Parliament and the Council on the assessment of the effects of certain public and private projects on the environment, as amended by Directive 2014/52/EU of the European Parliament and of the Council of 16 April 2014, and they have therefore prepared an Environmental Statement.

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 9(1)(c), (d) and (f) and 70(1) of the Roads (Scotland) Act 1984^(a) and all other powers enabling them to do so.

In accordance with section 71(3) of that Act, they are satisfied that another reasonably convenient means of access is available or will be provided before the access is stopped up pursuant to this Order.

They have determined that the project falls within Annex II to Directive 2011/92/EU of the European Parliament and the Council^(b) on the assessment of the effects of certain public and private projects on the environment and have published notice of that determination on 201[].

They have prepared an environmental statement and published notice of it on 201[]. This Order is made in compliance with the provisions of Parts I and III of Schedule 1^(c) to the Roads (Scotland) Act 1984.

Citation and commencement

1. This Order may be cited as the M8 (Junction 29A at A8 Greenock Road) Side Roads Order 201[] and comes into force on 201[].

Side roads, stopping up and new means of access

2. The definitions in Part 1 of the Schedule to this Order have effect.
3. The Scottish Ministers as roads authority are hereby authorised—
 - (a) to construct the length of road (hereinafter referred to as “the new side road”) along the route described in Part 2 of the Schedule;
 - (b) to stop up the means of access described in Part 3 of the Schedule when the new means of access described in Part 4 of the Schedule has been provided; and
 - (c) to provide the new means of access described in Part 4 of the Schedule.

Statutory undertakers

4. Where immediately before the date this Order comes into force there is under, in, on, over, along or across any lengths of road described in Part 2 of the Schedule any apparatus of a statutory undertaker, any rights of the statutory undertaker in respect of such apparatus shall be preserved.

Transfer of roads

5. On 1st April next after the date on which the new side road along the route described in Part 2 of the Schedule is open for the purpose of through traffic, the new side road shall be transferred to Renfrewshire Council(a) as roads authority for those roads and they shall enter those roads in their list of public roads(b).

SCHEDULE

Articles 2, 3, 4 and 5

PART 1 INTERPRETATION

In this Schedule:—

“the A8” means the Greenock Road;

“the M8” means the M8/A8 Edinburgh - Greenock Trunk Road;

“the plan folio” means the plan folio comprised of the legend and the plan numbered SRO1 and entitled “The M8 (Junction 29A at A8 Greenock Road) Side Road Order 201[]”, signed with reference to this Order and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF;

“the plan” means the plan numbered SRO1 and entitled “The M8 (Junction 29A at A8 Greenock Road) Side Roads Order 201[]” in the plan folio;

“Reference Point A” means the point of the intersection of the centre line of the M8 and the centre line of the A8 Overbridge as shown on the plan.

PART 2 THE ROUTE OF THE NEW SIDE ROAD

1. From a point on the A8, 36 metres or thereby south east of Reference Point A, in a south easterly direction for a distance of 287 metres or thereby to a point 323 metres or thereby south east of Reference Point A and including the new roundabout as shown stippled and numbered “1” on the plan.

2. From a point on the A8, 35 metres or thereby north west of Reference Point A, in a north westerly direction for a distance of 688 metres or thereby to a point 723 metres or thereby north west of Reference Point A and including the new roundabout as shown stippled and numbered “2” on the plan.

PART 3 MEANS OF ACCESS TO BE STOPPED UP

3. The length of the existing Craigmuir Farm access road from a point on the A8, 448 metres or thereby north west of Reference Point A, in a north easterly direction for a distance of 86 metres or thereby to a point 458 metres or thereby north west of Reference Point A as shown by solid black infill and numbered “4” on the plan.

PART 4 NEW MEANS OF ACCESS

4. From a point on the proposed roundabout road 365 metres or thereby north west of Reference Point A in a north then generally westerly direction for a distance of 130 metres or thereby as shown by single hatching and numbered “3” on the plan.






The Scottish Ministers make the following Scheme in exercise of the powers conferred by sections 7, 8(2) and 10(1) of the Roads (Scotland) Act 1984(a) and all other powers enabling them to do so.

In accordance with section 7(7) of that Act, they have given due consideration to the requirements of local and national planning policy and to the requirements of agriculture and industry.

They have determined that the project is a relevant project within Annex II to Directive 2011/92/EU of the European Parliament and the Council(b) on the assessment of the effects of certain public and private projects on the environment and have published notice of that determination on 20[].

They have prepared an environmental statement and published notice of it on 201[]. This Scheme is made in compliance with the provisions of Parts II and III of Schedule 1(c) to the Roads (Scotland) Act 1984.

Citation and Commencement

1. This Scheme may be cited as the M8 (Junction 29A at A8 Greenock Road) Special Road Scheme 201[], and comes into force on 201[].

Special Road

2. The definitions in the Schedule to this Scheme have effect.

3. The Scottish Ministers as special road authority are, by means of this Scheme, authorised to provide a special road along the routes described in the Schedule, and such a road shall become a trunk road on the date this Scheme comes into force.

Classes of Traffic

4. Classes I and II of traffic set out in Schedule 3 to the Roads (Scotland) Act 1984 are prescribed for the purpose of the use of the special road, the routes of which are described in the Schedule.

INTERPRETATION

Articles 2, 3 and 4

In this Schedule—

“The M8” means the M8/A8 Edinburgh – Greenock Trunk Road;

“Reference Point A” means the point of the intersection of the centre line of the M8 and the centre line of the A8 Overbridge as shown on plans PS1 and PS2 in the plan folio;

“the plan folio” means the plan folio comprised of the key plan, legend and Plans PS1 and PS2 and entitled “The M8 (Junction 29A at Bishopton Connecting Roads) Special Road Scheme 201[]”, signed with reference to this scheme and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow.

THE ROUTES OF THE SPECIAL ROAD

1. From a point on the M8, 915 metres or thereby south of the point marked “Reference Point A” on plan PS1 in the plan folio, in a generally northerly direction for a distance of 747 metres or thereby to a point 13 metres or thereby south of the proposed roundabout east of the M8 as shown by a heavy black line marked “1” on plan PS1.

2. From a point on the M8, 496 metres or thereby south of the point marked “Reference Point A” on plan PS2 in the plan folio, in a generally northerly, then north westerly direction for a distance of 786 metres or thereby to a point 9 metres or thereby south of the proposed roundabout west of the M8 as shown by a heavy black line marked “2” on plan PS2.





ASSOCIATED ROAD PROPOSALS









