**The A90 Trunk Road (Laurencekirk North Junction Improvements)
Order 2011**

<i>Made</i>	<i>17th May 2011</i>
<i>Coming into force</i>	<i>27th May 2011</i>

The Scottish Ministers make the following Order in exercise of the powers conferred by section 5(2) of the Roads (Scotland) Act 1984(a) and all other powers enabling them to do so.

In accordance with section 5(2) of that Act, they have taken into consideration the requirements of local and national planning including the requirements of agriculture and industry and are satisfied as to expediency.

In accordance with sections 20A(b) and 55A(c) of that Act, they have determined that the project falls within Annex II to Council Directive 85/337/EEC(d) on the assessment of the effects of certain public and private projects on the environment but having regard to the selection criteria contained in Annex III it should not be made subject to an environmental impact assessment in accordance with the Directive.

They have complied with the requirements of Part I of Schedule 1(e) to that Act.

1. This Order may be cited as the A90 Trunk Road (Laurencekirk North Junction Improvements) Order 2011 and comes into force on 27th May 2011.

Trunk Road

2. The length of road which the Scottish Ministers propose to construct along the route described in the Schedule shall become a trunk road on the date of the coming into force of this Order.

SCHEDULE

Article 2

INTERPRETATION

In this Schedule “the plan” means the plan entitled “The A90 Trunk Road (Laurencekirk North Junction Improvements) Order 2011” signed with reference to this Order and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF.

THE ROUTE OF THE NEW TRUNK ROAD

From a point 236 metres or thereby north east of the northern most corner of the building known as 3 Conveth Mains Cottages, Laurencekirk, Aberdeenshire AB30 1RR in a generally north-easterly direction for a distance of 20 metres or thereby to a point 256 metres or thereby north-east of the northern most corner of the building known as 3 Conveth Mains Cottages, Laurencekirk, Aberdeenshire AB30 1RR as shown by a heavy black line between points marked “point A” and “point B” on the plan.


THE A90 TRUNK ROAD (LAURENCEKIRK NORTH JUNCTION IMPROVEMENTS)

NOTICE IS HEREBY GIVEN, that the Scottish Ministers have made the following Orders:

1. The A90 Trunk Road (Laurencekirk North Junction Improvements) Trunk Road Order 2011 under section 5(2) of the Roads (Scotland) Act 1984, the general effect of which will be to provide for the construction of new trunk road, at Laurencekirk, Aberdeenshire.
2. The A90 Trunk Road (Laurencekirk North Junction Improvements) (Side Roads) Order 2011 under sections 12(1) and (5) of the Roads (Scotland) Act 1984, the general effect of which will be to provide for the construction of a new side road and the improvement of an existing length of road.

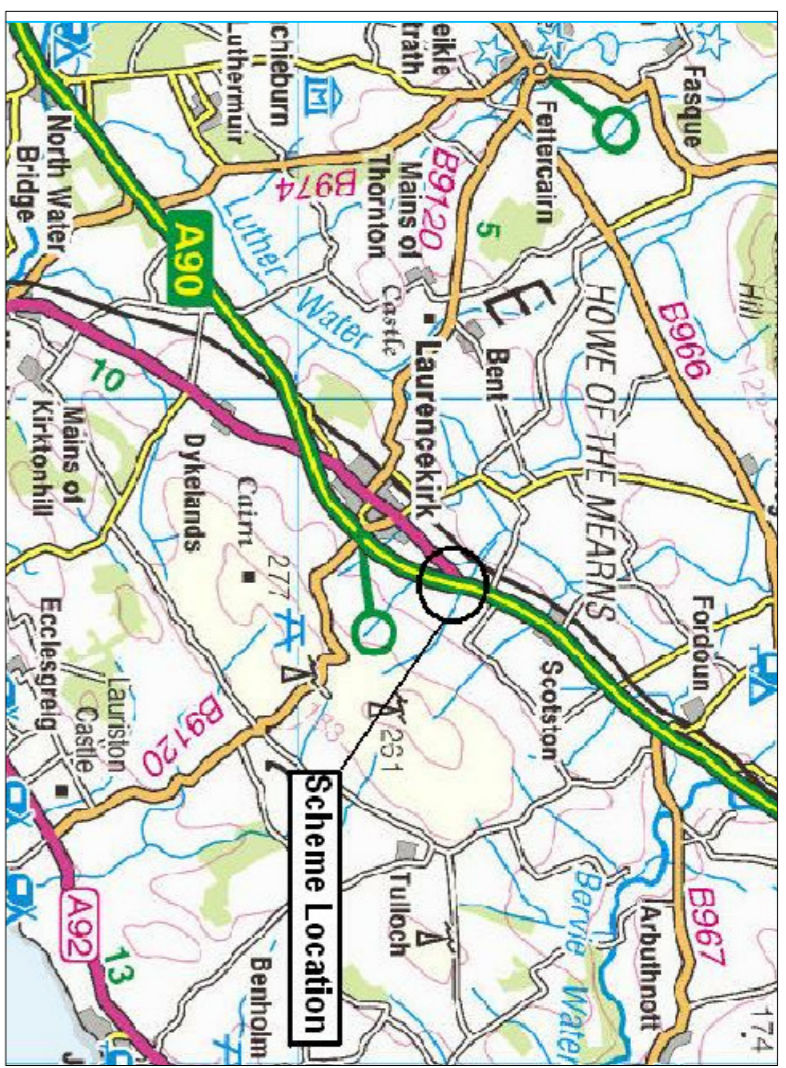

ANY PERSON aggrieved by the Order who desires to question the validity thereof, or of any provision therein on the grounds that they are not within the powers of the Roads (Scotland) Act 1984 or that any requirement of the said Act has not been complied with in relation to the Order may, within 6 weeks of 24th May 2011, make application to the Court of Session for the suspension of the operation of, or the quashing of, the Order or any provision contained therein.

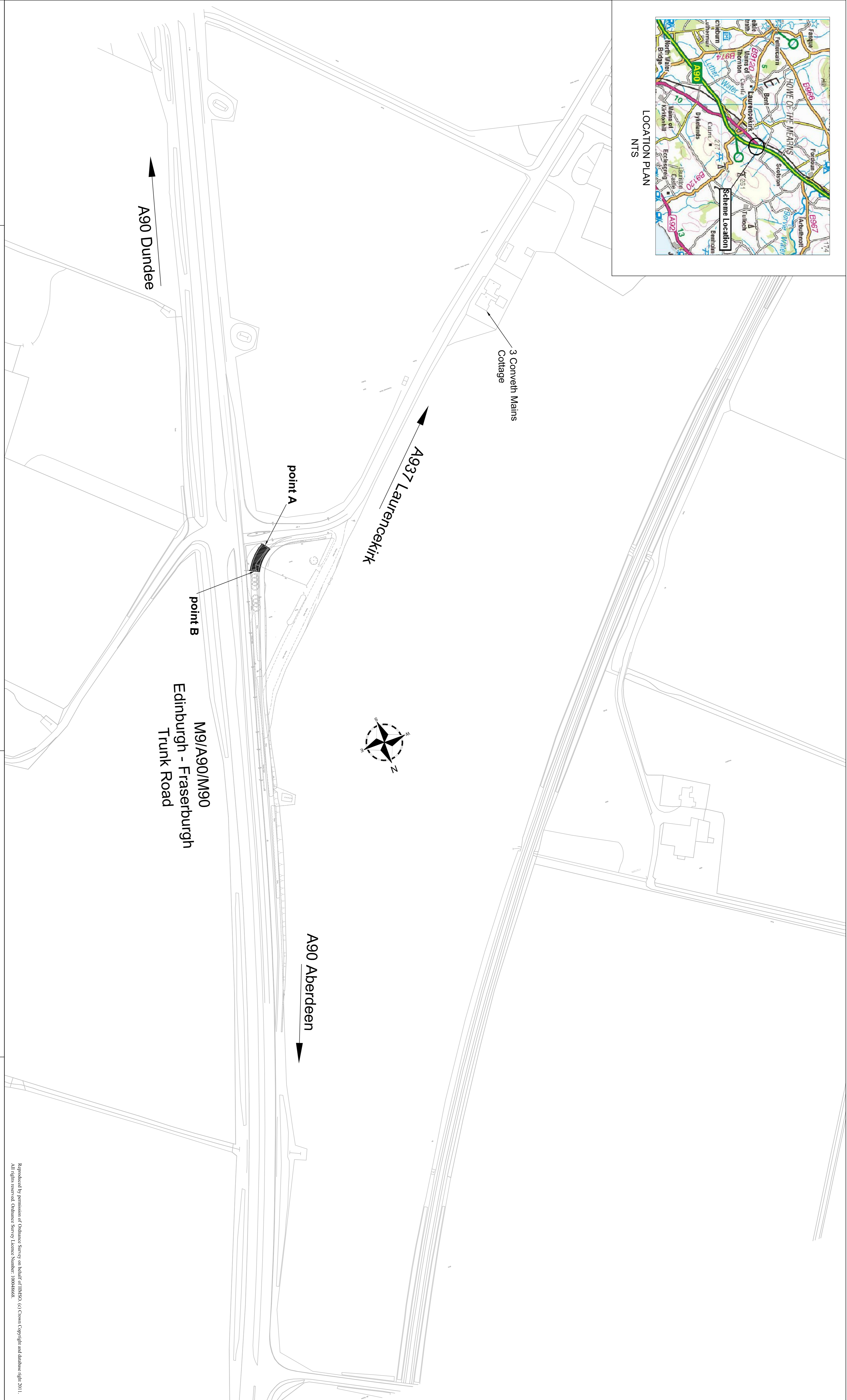

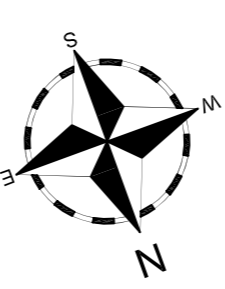

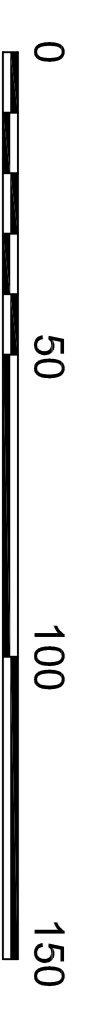
