The Scottish Ministers make the following Order in exercise of the powers conferred by sections 5(2) and (6) of the Roads (Scotland) Act 1984(a), and all other powers enabling them to do so.

In accordance with section 5(2) of that Act, they are satisfied as to expediency.

They have complied with the requirements of Part I of Schedule (b) of that Act.

Citation and commencement

1. This Order may be cited as the A92/A972 Trunk Road (South Marketgait, Dundee) (Detrunking) Order 2010, comes into force on 25th January 2010.

Road Ceasing to be a Trunk Road

2. On the date of coming into force of this Order the lengths of road described in the Schedule shall cease to be a trunk road and Dundee City Council (a) shall become the roads authority for those lengths of road and shall enter those lengths of road in their list of public roads.

INTERPRETATION

In this Schedule the following expressions have the following meanings: -

"the plan" means the plan numbered 07/NE/0101/025/801 entitled "The A92/A972 Trunk Road (South Marketgait, Dundee) (Detrunking) Order 2010", signed with reference to this Order and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF.

"the A92/A972 Trunk Road" means that length of the A92/A972 Kirkcaldy to Dundee Trunk Road also known as the Dundee Inner Ring Road (A991)

LENGTHS OF ROAD CEASING TO BE TRUNK ROAD

- 1. That length of the A92/A972 Trunk Road, eastbound carriageway at South Marketgait, Dundee from a point 173 metres or thereby east of Riverside Roundabout proceeding northeastwards, for a distance of 224 metres or thereby, as indicated by the black and white hatching between points A and B on the plan.
- 2. That length of the A92/A972 Trunk Road, eastbound and westbound carriageways at South Marketgait, Dundee from a point 82 metres or thereby southwest of Trades Lane, Dundee proceeding northeastwards, for a distance of 50 metres or thereby, as indicated by black and white hatching between points B and C on the plan

The A92/A972 Trunk Road (South Marketgait, Dundee)(Detrunking) Order 2010 the general effect of which will be the detrunking of existing trunk road.

ANY PERSON aggrieved by the Order who desires to question the validity thereof, or of any provision therein on the grounds that they are not within the powers of the Roads (Scotland) Act 1984 or that any requirement of the said Act has not been complied with in relation to the Order may within 6 weeks of the making of the Order make application to the Court of Session for the suspension of the operation of, or the quashing of, the Order or any provision contained therein.
