ROAD TRAFFIC

The A96 Trunk Road (Alexandra Road, Elgin) (Prohibition of Specified Turns) Order 2011

Coming into force

4th March 2011 14th March 2011

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 1(1), 2(1) and 2(2) of the Road Traffic Regulation Act 1984(a) and of all other powers enabling them to do so.

They have have complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b).

Citation and commencement

1. This Order may be cited as the A96 Trunk Road (Alexandra Road, Elgin) (Prohibition of Specified Turns) Order 2011 and comes into force on 14th March 2011.

Prohibition of use of vehicles

2. Subject to Articles 3 and 4 of this Order, no person shall use, or cause or permit the use of, any vehicle on the length of road specified in Part 1 of the Schedule to this Order so as to make any turn specified in Part 2 of the Schedule to this Order.

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

SCHEDULE

PART 1

That length of the A96 Aberdeen–Inverness Trunk Road (Alexandra Road, Elgin) from a point 61 metres or thereby west of the extended west kerbline at the Bus Station entrance to a point 82 metres or thereby west of the extended west kerbline at the Bus Station entrance, a distance of 21 metres or thereby.

PART 2

All right turns from Alexandra Road eastbound carriageway into North Street, Elgin.

Permission or direction of Police Constable

3. No provision of this Order shall apply to anything done with the permission or upon the direction of a police constable in uniform.

Exemption for emergency vehicles

4. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes.
