ROAD TRAFFIC

The A96 Trunk Road (Elgin) (30mph Speed Limit) Order 2011

Made

28th January 2011

Coming into force

7th February 2011

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 84(1)(a) and 124(1)(d) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

They have complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b).

Citation and commencement

1. This Order may be cited as the A96 Trunk Road (Elgin) (30mph Speed Limit) Order 2011 and shall come into force on 7th February 2011.

Restriction of Speed

2. No person shall drive any motor vehicle at a speed exceeding 30mph on the length of road specified in the Schedule to the Order.

Revocations

3. The following Orders are revoked—

(a) The Perth–Aberdeen–Inverness Trunk Road (Route A96) (Elgin Relief Road) (40mph Speed Limit) Order 1981(e);

(a) 1984 c.27, section 84(1) was substituted by the Road Traffic Act 1991 (c.40), section 45(2). The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (c.27) (as inserted by the New Roads and Street Works Act 1991 (c.22), Schedule 8, paragraph 70, which was amended by the Scotland Act 1998 (Consequential Modifications) Order 2001 (S.I. 2001/1400)) as read with section 151(1) of the Roads (Scotland) Act 1984 (c.54). The functions of the Secretary of State were transferred to the Scottish Ministers by the Scotland Act 1998 (Transfer of Functions to the Scottish Ministers etc.) Order 1999 (S.I. 1999/1750).


