#### ROAD TRAFFIC

The A96 Trunk Road (Moss Street, Keith) (Prohibition of Waiting and Loading) Order 2008

Made

11th November 2008

Coming into force

21st November 2008

The Scottish Ministers make the following Order in exercise of the powers conferred by section 1, 2(1) and 2(2) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

They have complied with the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b).

#### Citation and commencement

1. This Order may be cited as the A96 Trunk Road (Moss Street, Keith) (Prohibition of Waiting and Loading) Order 2008 and shall come into force on 21<sup>st</sup> November 2008.

#### Prohibition of use of vehicles

2. Subject to Articles 3 and 4, no person shall use or cause or permit the use of any vehicle to wait or to load at any time on any of the lengths of roads specified in the Schedule.

### Permission or direction of Police Constable

3. No provision of this Order shall apply to anything done with the permission or upon the direction of a police constable in uniform.

## Exemption for emergency and works vehicles

4. No provision of this Order shall apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes or a vehicle being used for carrying out the works.


#### **SCHEDULE**

On the following length of the west side of the A96 Aberdeen – Inverness Trunk Road, Keith:-

1. From a point 0.6 metres or thereby south of the extended north gable of number 139 Moss Street southwards to a point 1.4 metres or thereby south of the extended south gable of 130 Moss Street, a distance of 90.7 metres or thereby.

On the following lengths of the east side of the A96 Aberdeen – Inverness Trunk Road, Keith:-

- 1. From a point in line with the north gable of number 139 Moss Street southwards to a point 1.3 metres or thereby south of the extended south gable of number 130 Moss Street, a distance of 91 metres or thereby.
- 2. From a point 25 metres or thereby south of the extended north gable of 139 Moss Street southeastwards to a point 0.43 metres or thereby west of the projected front gable of Number 137 Moss Street, a distance of 7.7 metres or thereby.
- 3. From a point 44.7 metres or thereby south of the extended north gable of number 139 Moss Street northeastwards to a point 1.17 metres or thereby east of the projected front gable of Number 137 Moss Street, a distance of 8.9 metres or thereby.
