The M90/A90 Trunk Road (Spittalburn to Southbank) (Redetermination of Means of Exercise of Public Right of Passage) Order 2010

Made

19th February 2010

Coming into force

1st March 2010

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and 152(2) of the Roads (Scotland) Act 1984(a) and all other powers enabling them to do so.

Citation, commencement and interpretation

1. (1) This Order may be cited as the M90/A90 Trunk Road (Spittalburn to Southbank) (Redetermination of means of exercise of public right of passage) Order 2010 and comes into force on 1st March 2010.
- (2) In this Order “the Plan” means the Plan numbered RYC/MMC/A90 and entitled “The M90/A90 Trunk Road (Spittalburn to Southbank) (Redetermination of Means of Exercise of Public Right of Passage) Order 2010, signed with reference to this Order and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF.

Redetermination of Means of Exercise of Public Right of Passage

2. The part of road in Angus as specified in the Schedule, at present a footway, shall become a cycle track, the right of passage being exercisable on pedal cycle and foot only.

SCHEDULE

Article 2

Road over which means of exercise of public right of passage is to be redetermined – Angus

That length of footway from a point 470 metres or thereby south of the C55/A932 junction, Forfar (at the Lochlands Caravan Park and Garden Centre, Forfar) along the western channel of the C55 carriageway, to a point in a generally west direction a distance of 60 metres or thereby, and then in a generally south direction to a point a distance of 1019 metres or thereby along the footway located on the east verge of the A90 Trunk Road, as shown by the 'sawtooth' hatching between points marked A and B on the Plan.

The Order comes into operation on 1st March 2010.


