### ROAD TRAFFIC

The A82 Trunk Road (Belford Road/Inverlochy Place, Fort William) (Temporary Prohibition on Waiting, Loading and Unloading) Order 2013

Made

3rd May 2013

Coming into force

11th May 2013

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

#### Citation, commencement and cessation

1. This Order may be cited as the A82 Trunk Road (Belford Road/Inverlochy Place, Fort William) (Temporary Prohibition on Waiting, Loading and Unloading) Order 2013, comes into force on 11th May 2013 and ceases to have effect on 31st May 2013.

#### Prohibition on waiting, loading and unloading

2. No person may use, or permit the use of, any vehicle to wait, load or unload on the length of road, or a part or parts of the length of road, specified in the Schedule when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of one or more of the traffic signs prescribed in Diagrams 636 and 636.1 of the Traffic Signs Regulations 2002(b).

#### Exemptions

- 3. No prohibition imposed by this Order applies to-
  - (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
  - (b) a vehicle being used for carrying out the works.

## SCHEDULE 1

Article 2

# SPECIFIED LENGTH OF ROAD

That length of the A82 Dalnottar - Inverness Trunk Road from its junction with Belford Road/Nevis Bridge roundabout, Fort William in a southwestardly direction through Inverlochy Place to the Morrisons Roundabout, Fort William, a distance of 880 metres or thereby.

### PRESS NOTICE

THE A82 (BELFORD ROAD/INVERLOCHY PLACE, FORT WILLIAM) (TEMPORARY PROHIBITION OF WAITING AND LOADING) ORDER 2013

THE SCOTTISH MINISTERS give notice that they have made the above Order temporarily prohibiting traffic from waiting or loading on that length of the A82 Dalnottar - Inverness Trunk Road from its junction with Belford Road/Nevis Bridge roundabout, Fort William in a southwestwardly direction through Inverlochy Place to the Morrisons Roundabout, Fort William, a distance of 880 metres or thereby.

The Order, which is required because works are being or are proposed to be executed on or near the said length of road to allow essential road resurfacing to take place, will be in operation from 11<sup>th</sup> May 2013 until midnight on 30<sup>th</sup> May 2013 but will only have effect in relation to such part or parts of the lengths of road as are indicated by the appropriate traffic signs. The Order does not apply to works vehicles or vehicles being used in an emergency for fire brigade, coastguard, ambulance or police purposes or to acts done with the permission or upon the direction of a police constable in uniform.
