ROAD TRAFFIC

**The A85 Trunk Road (Comrie) (Temporary Prohibition on
Waiting, Loading and Unloading) Order 2013**

<i>Made</i>	- - -	<i>22nd August 2013</i>
<i>Coming into force</i>	- -	<i>1st September 2013</i>

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that traffic on the length of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A85 Trunk Road (Comrie) (Temporary Prohibition on Waiting, Loading and Unloading) Order 2013, comes into force on 1st September 2013 and ceases to have effect on 1st January 2014.

Prohibition on waiting, loading and unloading

2. No person may use, or permit the use of, any vehicle to wait, load or unload on the length of road, or a part or parts of the length of road, specified in the Schedule when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of one or more of the traffic signs prescribed in Diagrams 636 and 636.1 of the Traffic Signs Regulations 2002(b).

The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (inserted by the New Roads and Street Works Act 1991, Schedule 8, paragraph 70 and amended by S.I. 2001/1400) as read with section 151(1) of the Roads (Scotland) Act 1984 (c.54). The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
- (b) a vehicle being used for carrying out the works.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A85 Perth – Lochearnhead Trunk Road from the access road to Tomperran, Comrie, in a westerly direction through Drummond Street, Dunira Street, Dundas Street and Burrell Street, Comrie, to the west access road into Twenty Shilling Wood Caravan Site, Comrie, a distance of 2.496 kilometres or thereby.

PRESS NOTICE

THE A85 (COMRIE) (TEMPORARY PROHIBITION ON WAITING, LOADING AND UNLOADING) ORDER 2013

THE SCOTTISH MINISTERS give notice that they have made the above Order temporarily prohibiting traffic from waiting, loading or unloading on that length of the A85 Perth – Lochearnhead Trunk Road from the access road to Tomperran, Comrie, in a westerly direction through Drummmond Street, Duntara Street, Dundas Street and Burrell Street, Comrie, to the west access road into Twenty Shilling Wood Caravan Site, Comrie, a distance of 2.496 kilometres or thereby.

The Order, which is required because works are being or are proposed to be executed on or near the same length of road to allow relining works to take place, will be in operation from 1st September 2013 until 1st January 2014 but will only have effect in relation to such part or parts of the length of road as indicated by the appropriate traffic signs. The Order does not apply to works vehicles or vehicles being used in an emergency for fire brigade, coastguard, ambulance or police purposes or to acts done with the permission or upon the direction of a police constable in uniform.
