**The A85 Trunk Road (Stafford Street, Oban) (Detrunking) Order
201[]**

Made - - - - 201[]
Coming into force - - - 201[]

The Scottish Ministers make the following Order in exercise of the powers conferred by section 5(2) and (6) of the Roads (Scotland) Act 1984(a), and all other powers enabling them to do so.

In accordance with section 5(2) of that Act, they have taken into consideration the requirements of local and national planning, including the requirements of agriculture and industry and are satisfied as to expediency.

This Order is made in accordance with the provisions of Parts I and III of Schedule 1(b) to that Act.

Citation and commencement

1. This Order may be cited as the A85 Trunk Road (Stafford Street, Oban) (Detrunking) Order 201[], and comes into force on 201[].

Road Ceasing to be Trunk Road

2. On the date this Order comes into force the lengths of road described in the Schedule to this Order shall cease to be trunk road and Argyll and Bute Council(**a**) shall become the roads authority for those lengths of road and shall enter those lengths of road in their list of public roads(**b**).

SCHEDULE

Articles 2

Interpretation

3. In this Schedule—

“the A85 Trunk Road” means the A85 Tyndrum - Oban Trunk Road;

“the plan” means the plan numbered 01/NW/001 entitled “the A85 Trunk Road (Stafford Street, Oban) (Detrunking) Order 20[]”, signed with reference to this Order and deposited at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF.

Lengths Of Road Ceasing To Be Trunk Road

4. Those lengths of the A85 Trunk Road, from the intersection point of the extended south kerbline of Corran Esplanade, Oban and the extended east kerbline of Stafford Street, Oban, eastwards to the intersection of the extended north kerbline of George Street and the extended east kerbline of Stafford Street, Oban a distance of 47 metres or thereby, as shown by black and white hatching between points A and B on the plan.


**THE A85 TRUNK ROAD (STAFFORD STREET, OBAN)

NOTICE IS HEREBY GIVEN, that the Scottish Ministers propose to make the following Order:

The A85 Trunk Road (Stafford Street, Oban) (Detrunking) Order 2011] under section 5(2) and (6) of the Roads (Scotland) Act 1984, the general effect of which will be the detrunking of the A85 Tyndrum - Oban Trunk Road at Stafford Street, Oban, as described in the Schedule to the Order.

COPIES of the proposed Order together with the relevant plan may be inspected, free of charge, during normal business hours, from 8th November 2013 until 20th December 2013 at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF; the offices of Argyll and Bute Council, Kilmory, Lochgilphead, Argyll, PA31 8RT; and Oban Library, 77 Albany St, Oban PA34 4AL.

Any such notice must be received on or before 20th December 2013.
