**ROAD TRAFFIC**

**The North West Scotland Trunk Roads (Temporary Prohibitions  
of Traffic and Overtaking and Temporary Speed Restrictions)  
(No. 5) Order 2013**

*Made* - - - - - *20th May 2013*

*Coming into force* - - - - - *1st June 2013*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1), 14(1)(a) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the lengths of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near the said lengths of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the North West Scotland Trunk Roads (Temporary Prohibitions of Traffic and Overtaking and Temporary Speed Restrictions) (No. 5) Order 2013, comes into force on 1st June 2013 and ceases to have effect on 1st September 2013.

**Interpretation**

2. In this Order a reference to a numbered column is to the column in the Schedule bearing that number.

**Prohibition on use of a road**

3. No person may use, or permit the use of, any vehicle on a length of road or part or parts of a length of road, specified in column 1 when a prohibition is identified as applying to that length of

road, or a part or parts of that length of road, by means of one or more of the traffic signs prescribed in Diagrams 7010.1 and 7105 of the Traffic Signs Regulations 2002(a).

#### **Prohibition on overtaking**

4.—(1) No person may use, or permit the use of, any vehicle in such a way that it overtakes any other moving vehicle on a length of road, or a part or parts of a length of road, specified in column 1 when a prohibition is identified as applying to that length of road, or a part or parts of a length of road, by means of a traffic sign prescribed in Diagram 632 of the Traffic Signs Regulations 2002.

(2) "Other moving vehicle" does not include a cycle, motor cycle, tricycle or any other vehicle not being a motor vehicle in accordance with section 140 of the Road Traffic Regulation Act 1984(b).

#### **Speed restriction**

5.—(1) No person may drive any vehicle on the lengths of road, or a part or parts of a length of road, specified in column 1 of the Schedule at a speed exceeding that specified in column 2 when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002.

(2) When convoy working is in operation and indicated by one or more of the traffic signs prescribed in Diagrams 7011, 7025, 7026, 7027, 7028 and 7029 of the Traffic Signs Regulations 2002, no person may drive any vehicle on a length of road, or a part or parts of a length of road specified in column 1 of the Schedule at a speed exceeding 10 miles per hour when such a restriction is identified as applying to any part or parts of that length of road by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002.

#### **Exemptions**

6. No prohibition imposed by this Order applies to vehicles being used in an emergency for fire brigade, ambulance, police or coastguard purposes or a vehicle while being used for carrying out the works.

7. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(c) when used in accordance with regulation 3(5) of those Regulations.

4. That length of the A83 Tarbet – Lochgilphead – Kennacraig Trunk Road, from its junction with Kilmory Industrial Estate roundabout, Lochgilphead, southwards to the access road to Castleton, a distance of 2.744 kilometres or thereby.
5. That length of the A83 Tarbet – Lochgilphead – Kennacraig Trunk Road, from its junction with the A819 Inveraray Road, Inveraray, eastwards to the A815 Dunoon junction a distance of 17.243 kilometres or thereby.
6. That length of the A84/A85 Stirling – Crianlarich Trunk Road from its junction with the M9/A9 Edinburgh – Stirling – Thurso Trunk Road at Craigforth Roundabout, Stirling northwards to its junction with the unclassified road to Cambusdrenny, a distance of 1.320 kilometres or thereby.
7. That length of the A85 Perth – Lochearnhead Trunk Road from its junction with the Newhouse Road/Crieff Road roundabout, Perth, eastwards to the access road to Huntingtower Castle, East Huntingtower, a distance of 732 metres or thereby.
8. That length of the A85 Perth – Lochearnhead Trunk Road from its junction with the A84/A85 Stirling – Crianlarich Trunk Road eastwards to the access road to Dalveich, a distance of 2.744 kilometres or thereby.
9. That length of the A85 Tyndrum – Oban Trunk Road from its northernmost junction with the A819 Inveraray Road westwards to the access road to Cruachan power station, a distance of 7.841 kilometres or thereby.
10. That length of the A87 Invergarry – Kyle of Lochalsh – Borve – Uig Trunk Road from the access road to Balnaknock southwards to the access road to Cuidrach, a distance of 4.087 kilometres or thereby.
11. That length of the A87 Invergarry – Kyle of Lochalsh – Borve – Uig Trunk Road from the access road to Luib southwestwards and northwards to the west access road to Sconser, a distance of 10.925 kilometres or thereby.
12. That length of the M9/A9 Edinburgh – Stirling – Thurso Trunk Road from the private access to Dunachton Lodge northwards to the B970 Lynwilg junction, a distance of 8.204 kilometres or thereby.
13. That length of the M9/A9 Edinburgh – Stirling – Thurso Trunk Road from its junction with the southbound off slip to Raigmore Interchange, Inverness, being both carriageways southwards to the B8082 Beechwood access, Inverness, a distance of 1.514 kilometres or thereby.
14. That length of the M9/A9 Edinburgh – Stirling – Thurso Trunk Road from its junction with the A9 northbound off slip to Luncarty being both carriageways to the access road to Stanley, a distance of 3.648 kilometres or thereby.
