**The North West Scotland Trunk Roads (Temporary Prohibitions
of Traffic and Overtaking and Temporary Speed Restrictions)
(No. 10) Order 2012**

Made - - - - *22nd October 2012*

Coming into force - - *1st November 2012*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1), 14(1) and (4) of the Road Traffic Regulation Act 1984^(a) and all other powers enabling them to do so.

In accordance with section 14(1) of that Act, they are satisfied that the traffic on the lengths of road specified in the Schedule should be restricted or prohibited because works are being or are proposed to be executed on or near those lengths of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the North West Scotland Trunk Roads (Temporary Prohibitions of Traffic and Overtaking and Temporary Speed Restrictions) (No. 10) Order 2012, comes into force on 1st November 2012 and ceases to have effect on 1st February 2013.

Interpretation

2. In this Order a reference to a numbered column is to the column in the Schedule bearing that number.

Temporary prohibition on use of a road

3. No person shall use, or permit the use of, any vehicle on a length of road, or a part or parts of a length of road, specified in column 1 when a prohibition is identified as applying to that length

of road, or a part or parts of that length of road, by means of one or more of the traffic signs prescribed in Diagrams 7010.1 and 7105 of the Traffic Signs Regulations 2002(a).

Temporary prohibition on overtaking

4.—(1) No person shall use, or permit the use of, any vehicle in such a way that it overtakes any other moving vehicle on a length of road, or a part or parts of a length of road, specified in column 1 when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign prescribed in Diagram 632 of the Traffic Signs Regulations 2002.

(2) “Other moving vehicle” does not include a cycle, motor cycle, tricycle or any other vehicle not being a motor vehicle in accordance with section 140 of the Road Traffic Regulation Act 1984(b).

Temporary speed restriction

5.—(1) No person shall drive any vehicle on a length of road, or a part or parts of a length of road, specified in column 1 of Part 2 of the Schedule at a speed exceeding that specified in column 2 when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002.

(2) When convoy working is in operation and indicated by one or more of the traffic signs prescribed in Diagrams 7011, 7025, 7026, 7027, 7028 and 7029 of the Traffic Signs Regulations 2002, no person shall drive any vehicle on a length of road, or a part or parts of a length of road, specified in column 1 of Part 2 of the Schedule at a speed exceeding 10 mph when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations 2002.

Exemptions

6. No prohibition imposed by this order applies to vehicles being used in an emergency for fire brigade, ambulance, police or coastguard purposes or a vehicle while being used for carrying out the works.

7. No speed restriction imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(c) when used in accordance with regulation 3(5) of those Regulations.

PRESS NOTICE

THE SCOTTISH MINISTERS give notice that they have made the following Orders temporarily prohibiting traffic, temporarily prohibiting overtaking and temporarily restricting the speed of vehicles on the lengths of road identified in this Notice.

The Orders, which are required because works are being or are proposed to be executed on or near the lengths of road, will be in operation from **1st November 2012 until 1st February 2013, unless otherwise stated, but will only have effect in relation to such part or parts of the lengths of road as indicated by the appropriate traffic signs.** The provisions relating to temporary prohibitions of traffic do not apply to vehicles being used in an emergency for fire brigade, ambulance, police or coastguard purposes or vehicles used for carrying out the works. There are no exemptions for those vehicles in respect of temporary prohibitions of overtaking and temporary speed restrictions unless otherwise provided by law. The provisions relating to temporary speed restrictions do not apply to vehicles being used in the service of the Special Forces.

Where the closure of a carriageway on a dual carriageway road is involved the alternative route for traffic will be the adjacent carriageway by means of contraflow working. **Other alternative route or routes for traffic in relation to the lengths of road affected by the Orders during a prohibition will be signposted.** Detailed descriptions of the alternative routes and the works being carried out can also be obtained at the following offices:

THE NORTH WEST SCOTLAND TRUNK ROADS (TEMPORARY PROHIBITIONS OF TRAFFIC AND OVERTAKING AND TEMPORARY SPEED RESTRICTIONS) (No.10) ORDER 2012

The following lengths of the A82 Dalnottar – Inverness Trunk Road:

1. From its junction with General Booth Road, Inverness southwards to its junction with unclassified road to Abriachan, a distance of 12.338 kilometres or thereby.

Prohibitions on use and overtaking.

2. From its junction with the A84/A85 Stirling – Crianlarich Trunk Road at Crianlarich northwestwards to its junction with the A85 Tyndrum – Oban Trunk Road at Tyndrum, a distance of 8.13 kilometres or thereby.

3. From its junction with the A828 Connel – South Ballachulish Trunk Road at South Ballachulish Roundabout, South Ballachulish, eastwards to its junction with the unclassified road to Glen Etive at the west side of Rannoch Moor, a distance of 21.93 kilometres or thereby.

4. From its junction with the A86 Spean Bridge – Kingussie Trunk Road at Spean Bridge northwards to its junction with the A87 Invergarry – Kyle of Lochalsh – Borve – Uig Trunk Road at Invergarry, a distance of 24.5 kilometres or thereby.

5. From its junction with the A887 Invermoriston – Moriston Bridge Trunk Road to its junction with the A831 Milton Road at Drumnadrochit, a distance of 20.46 kilometres or thereby.

Prohibitions on use and overtaking and a 30 mph speed restriction and 10 mph restriction when there is convoy working.

The following lengths of the A828 Connel – South Ballachulish Trunk Road:

6. From its junction with the B845 Achineir Road, south of Barcaldine, southwards to the access road to Keil Crofts in Benderloch, a distance of 6.453 kilometres or thereby.

Prohibitions on use and overtaking.

The following lengths of the A83 Tarbet – Lochgilphead – Kennacraig Trunk Road:

7. That length of the A83 Tarbet – Lochgilphead – Kennacraig Trunk Road from its western access of Kintyre Street, Tarbert northwards to access road to the electricity Sub Station on Barmore Road, Tarbert, a distance of 739 metres or thereby.

Prohibitions on use and overtaking.

8. From its junction with the A819 Dalmally Road at Inveraray, southwestwards to its junction with the unclassified road to Minard Castle, south of Minard, a distance of 20.25 kilometres or thereby.

Prohibitions on use and overtaking and a 30 mph speed restriction and 10 mph restriction when there is convoy working.

The following length of the A830 Fort William – Mallaig Trunk Road:

9. From its junction with the A861 Glenuig Road at Lochailort westwards to its termination at its junction with Station Road, Mallaig Roundabout, a distance of 25.35 kilometres or thereby.

Prohibitions on use and overtaking and a 30 mph speed restriction and 10 mph restriction when there is convoy working.

The following length of the A835/A893 Tore – Ullapool Trunk Road:

10. From its northernmost junction with the A832 Dundonnell Road at Corrieshalloch Gorge southeastwards to its junction with the A832 Achanalt Road, 375 metres or thereby south of its junction with the unclassified road to Little Garve, a distance of 30.7 kilometres or thereby.

Prohibitions on use and overtaking and a 30 mph speed restriction and 10 mph restriction when there is convoy working.

The following lengths of the A84/A85 Stirling – Crianlarich Trunk Road:

11. From its junction with the A85 Perth – Lochearnhead Trunk Road at Lochearnhead northwards to its junction with the A82 Dalnottar – Inverness Trunk Road at Crianlarich, a distance of 25.94 kilometres or thereby.

12. From its junction with the A821 Brig o’Turk Road at Kilmahog southeastwards to its junction with the unclassified road to Dalvorlich, by Callander, a distance of 4.62 kilometres or thereby.

Prohibitions on use and overtaking and a 30 mph speed restriction and 10 mph restriction when there is convoy working.

The following lengths of the A85 Perth – Lochearnhead Trunk Road:

13. From its junction with the A84/A85 Stirling – Crianlarich Trunk Road at Lochearnhead eastwards to Stirling Boundary at Tynreoch, a distance of 13.37 kilometres or thereby.

Prohibitions on use and overtaking and a 30 mph speed restriction and 10 mph restriction when there is convoy working.

The following length of the A85 Tyndrum – Oban Trunk Road:

14. From its junction with the B845 Kilchrenan Road at Taynuilt westwards to its junction with Corran Park Roundabout in Oban, a distance of 18.68 kilometres or thereby.

Prohibitions on use and overtaking and a 30 mph speed restriction and 10 mph restriction when there is convoy working.

The following lengths of the A86 Spean Bridge – Kingussie Trunk Road:

15. From its junction with the A889 Dalwhinnie – Laggan Bridge Trunk Road westwards to its junction with the M9/A9 Edinburgh – Stirling – Thurso Trunk at Kingussie, a distance of 18.214 kilometres or thereby

Prohibitions on use and overtaking.

16. From its junction with the A889 Dalwhinnie – Laggan Bridge Trunk Road at Drumgask Farm, south of Laggan Bridge, westwards to its junction with the unclassified road to Aberarder, by Kinloch Laggan, a distance of 15.94 kilometres or thereby.

Prohibitions on use and overtaking and a 30 mph speed restriction and 10 mph restriction when there is convoy working.

The following lengths of the A87 Invergarry – Kyle of Lochalsh – Borve – Uig Trunk Road:

17. From a point 14.7 kilometres or thereby west of its junction with the A887 Invermoriston – Moriston Bridge Trunk Road at Cluanie Lodge westwards to its junction with the unclassified road to Glenshiel Lodge at Shiel Bridge, a distance of 18.34 kilometres or thereby.

18. From its junction with the A863 Struan Road at the Sligachan Hotel, south of Portree, eastwards to its junction with the B8083 Elgol Road at Broadford, a distance of 26.15 kilometres or thereby.

Prohibitions on use and overtaking and a 30 mph speed restriction and 10 mph restriction when there is convoy working.

The following lengths of the M9/A9 Edinburgh – Stirling – Thurso Trunk Road:

19. From a point 3.9 kilometres or thereby north of Inveralmond Roundabout in Perth, northwards to a point 4.1 kilometres or thereby north of the southernmost junction with the B867 Bankfoot Road, south of Bankfoot, a distance of 8.61 kilometres or thereby.

20. The northbound and southbound carriageways from its junction with the A924 Kirkmichael Road, south of Pitlochry southwards to a point 750 metres or thereby south of its junction with the A827 Aberfeldy Road at Ballinluig, a distance of 5.89 kilometres or thereby.

21. From a point 4 kilometres or thereby north of its junction with the A924 Kirkmichael Road, north of Pitlochry northwards to a point 1.35 kilometres or thereby south of its junction with the unclassified Trinafour Road at Dalnacardoch Lodge, a distance of 21.02 kilometres or thereby.

22. From its junction with the A889 Dalwhinnie – Laggan Bridge Trunk Road at Wade Bridge, by Dalwhinnie, northwards to its junction with the A86 Spean Bridge – Kingussie Trunk Road at Kingussie, a distance of 24.18 kilometres or thereby.

23. The northbound and southbound carriageways from a point 15.5 kilometres or thereby north of its junction with the A95 Granish – Keith Trunk Road at Granish, northwards to a point 350 metres or thereby south of the northernmost junction to the unclassified road to Findhorn Bridge, south of Tomatin, a distance of 5.34 kilometres or thereby.

24. The northbound and southbound carriageways from its junction with the A82 Dalnottar – Inverness Trunk Road at Longman Roundabout in Inverness, northwards to its junction with the A835/A893 Tore – Ullapool Trunk Road at Tore Roundabout, in Tore, a distance of 9.78 kilometres or thereby.

25. From its southernmost junction with the A836 Ardgay Road at the southern end of Dornoch Bridge, west of Tain, northwards to its junction with the A839 Morvich Road at The Mound, west of Golspie a distance of 16.21 kilometres or thereby.

26. From its junction with the A897 Kinbrace Road at Helmsdale, northeastwards to its junction with the unclassified road to Ramsbraigs, a distance of 20.71 kilometres or thereby.

27. From its junction with the B870 Westerdale Road at Mybster, northwards to its termination at Scrabster Harbour, Scrabster, a distance of 20.6 kilometres or thereby.

Prohibitions on use and overtaking and a 30 mph speed restriction and 10 mph restriction when there is convoy working.
