ROAD TRAFFIC

The A68 Trunk Road (St Boswells) (30mph and 40mph Speed Limit) Order 2011

Made

7th July 2011

Coming into force

18th July 2011

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 84(1)(a) and 124(1)(d) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

Citation and commencement

1. This Order may be cited as the A68 Trunk Road (St Boswells) (30mph and 40mph Speed Limit) Order 2011 and comes into force on 18th July 2011.

Restriction of Speed

2.-(1) No person shall drive any motor vehicle at a speed exceeding 30mph on the length of road specified in Part 1 of the Schedule to this Order.

(2) No person shall drive any motor vehicle at a speed exceeding 40mph on the lengths of road specified in Part 2 of the Schedule.

Exemption

3. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(b) when used in accordance with regulation 3(5) of those Regulations.

4. The A68 Trunk Road (St Boswells) (40mph Speed Limit) Order 2009(a) is revoked.

PART 1

Article 2(1)

Length of Road to which 30 mph Speed Limit applies

That length of the A68 Edinburgh – Carter Bar Trunk Road at St Boswells from a point 117 metres or thereby south of its junction with the B6404 Main Street St Boswells to a point 180 metres or thereby north of the junction with the B6404 Main Street, St Boswells, a distance of 297 metres or thereby.

PART 2

Article 2(2)

Lengths of Road to which 40 mph Speed Limit applies

1. That length of the A68 Edinburgh – Carter Bar Trunk Road at St Boswells from a point 180 metres or thereby north of its junction with the B6404 Main Street St Boswells to a point 419 metres or thereby north of the junction with the B6404 Main Street, St Boswells, a distance of 239 metres or thereby.
2. That length of the A68 Edinburgh – Carter Bar Trunk Road at St Boswells from a point 117 metres or thereby south of its junction with the B6404 Main Street St Boswells to a point 100 metres or thereby south of the A699 Kelso junction, a distance of 238 metres or thereby.



The Scottish Minister make the following Order in exercise of the powers conferred by section 84(1)(a) and section 124(1)(d) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling them to do so.

They have complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b), before making this Order:

Citation and Commencement

1. This Order may be cited as the A68 Trunk Road (St Boswells) (40mph Speed Limit) Order 2009 and comes into force on 19th October 2009.

Restriction of Speed

2. No person shall drive any motor vehicle at a speed exceeding 40mph on the length of road specified in the Schedule to this Order.


