ROAD TRAFFIC

The A68 Trunk Road (St Boswells) (40mph Speed Limit) Order 2009

Made

8th October 2009

Coming into force

19th October 2009

The Scottish Minister make the following Order in exercise of the powers conferred by section 84(1)(a) and section 124(1)(d) of the Road Traffic Regulation Act 1984(a), and of all other powers enabling them to do so.

They have complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b), before making this Order:

Citation and Commencement

1. This Order may be cited as the A68 Trunk Road (St Boswells) (40mph Speed Limit) Order 2009 and comes into force on 19th October 2009.

Restriction of Speed

2. No person shall drive any motor vehicle at a speed exceeding 40mph on the length of road specified in the Schedule to this Order.

3. The A68 Trunk Road (St Boswells) (40mph Speed Limit) Order 2004(a) is hereby revoked.

The Scottish Ministers, in exercise of the powers conferred (a) by section 84(1)(a) as read with section 124(1)(d) of the Road Traffic Regulation Act 1984(b), and of all other powers enabling them in that behalf, and having complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(c), hereby make the following Order:

1. This Order may be cited as the A68 Trunk Road (St Boswells) (40mph Speed Limit) Order 2004 and shall come into force on 8th March 2004.
2. No person shall drive any motor vehicle at a speed exceeding 40mph on the length of road specified in the Schedule to this Order.
3. The A68 Trunk Road (St Boswells) (40mph Speed Limit) Order 1996 (d) is hereby revoked.

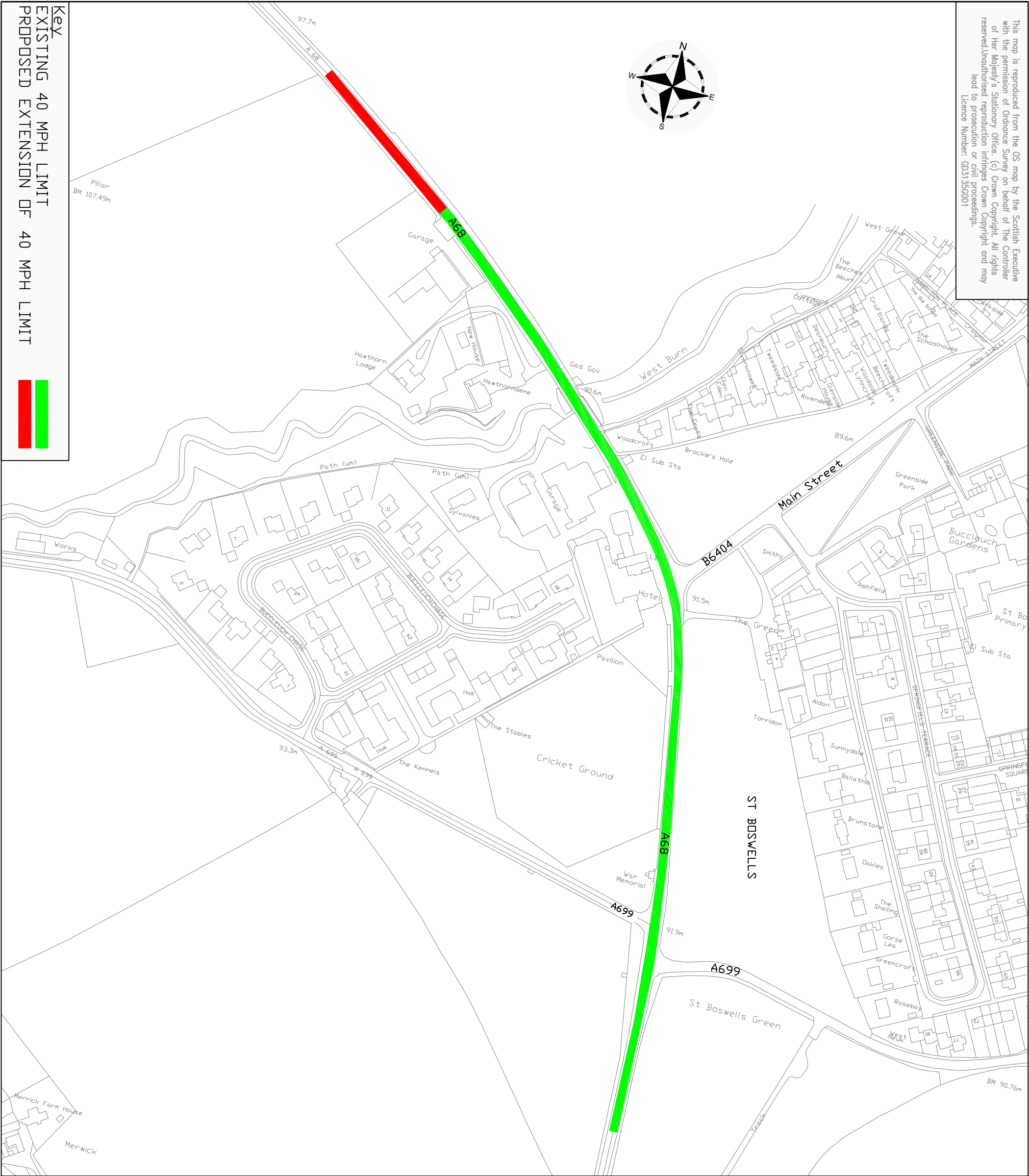
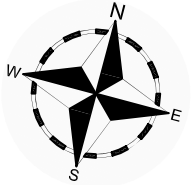
