The A77 Trunk Road (Girvan) (Restricted Roads) Order 2013

The Scottish Ministers make the following Order in exercise of the powers conferred by section 82(2)(b), 83(1), 124(1)(d) of, and paragraph 27 of Schedule 9, to the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 83(1) of the Road Traffic Regulation Act 1984, Scottish Ministers have given public notice of their intention to make the following Order, and have complied with Parts II and III of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b).

Citation and commencement

1. This Order may be cited as the A77 Trunk Road (Girvan) (Restricted Roads) Order 2013 and comes into force on 2013.

Direction that a length of road shall become a restricted road

2. It is directed that the lengths of road specified in the Schedule to this Order shall become restricted roads for the purpose of section 81 of the Road Traffic Regulation Act 1984, whereby imposing a 30 miles per hour speed restriction.

Revocation

3. The A77 Trunk Road (Girvan) (Restricted Roads) Order 2011(c) is revoked.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

1. That length of the M77/A77 Glasgow - Stranraer Trunk Road at Girvan, from a point 48 metres or thereby west of Shallochpark Roundabout eastwards then northwards to a point on Glendoune Street at the north extended north kerbline of Cauldershore, a distance of 545 metres or thereby.
2. From a point on Glendoune Street at the north extended north kerbline of Cauldershore northwards to a point on Dalrymple Street at the extended south kerbline of Knockcushan Street, a distance of 1178 metres or thereby.
3. From a point on Glendoune Street at the north extended north kerbline of Cauldershore northwards to a point on Henrietta Street at the extended south kerbline of Knockcushan Street, a distance of 1161 metres or thereby.
4. From a point on Knockcushan Street at the extended west kerbline of Henrietta Street eastwards to a point at the extended east kerbline of Dalrymple Street, a distance of 205 metres or thereby.
5. From a point 8 metres or thereby south of the extended north kerbline of Knockcushan Street at Bridge Street north-eastwards to a point 115 metres or thereby on the A77 north of Bridgemill Roundabout, a distance of 1074 metres or thereby.

THE A77 TRUNK ROAD (GIRVAN) (RESTRICTED ROADS) ORDER 2013

THE SCOTTISH MINISTERS hereby give notice that they propose to make the above Order under sections 84(1)(a) and 124(1)(d) and paragraph 27 of Schedule 9 to the Road Traffic Regulation Act 1984 which will have the effect of imposing a 30mph speed limit on the following lengths of road:

That length of the M77/A77 Glasgow - Stranraer Trunk Road at Girvan, from a point 48 metres or thereby west of Shallochpark Roundabout eastwards then northwards to a point on Glendoune Street at the north extended north kerbline of Cauldshore, a distance of 545 metres or thereby.

From a point on Glendoune Street at the north extended north kerbline of Cauldershore northwards to a point on Dalrymple Street at the extended south kerbline of Knockcushan Street, a distance of 1178 metres or thereby.

From a point on Glendoune Street at the north extended north kerbline of Cauldershore northwards to a point on Henrietta Street at the extended south kerbline of Knockcushan Street, a distance of 1161 metres or thereby.

From a point on Knockcushan Street at the extended west kerbline of Henrietta Street eastwards to a point at the extended east kerbline of Dalrymple Street, a distance of 205 metres or thereby.

From a point 8 metres or thereby south of the extended north kerbline of Knockcushan Street at Bridge Street north-eastwards to a point 115 metres or thereby on the A77 north of Bridgemill Roundabout, a distance of 1074 metres or thereby

The A77 Trunk Road (Girvan) (Restricted Roads) Order 2011 is revoked by this Order.

Full details of the proposal are contained in the Order which, together with a plan showing the length of road involved, a copy of the existing Order to be revoked and a statement of the Scottish Ministers' reasons for proposing to make the Order, may be examined free of charge during normal business hours from 20th August 2013 until 24th September 2013 at the offices of Transport Scotland, Buchanan House, 58 Port Dundas Road, Glasgow, G4 0HF, and Girvan Library, Montgomerie Street, Girvan, KA26 9HE.

Statement of The Scottish Ministers' Reasons for Promoting an
Extension to 30mph Speed Limit on the M77 / A77 Glasgow –
Stranraer Trunk Road at Girvan

The Scottish Ministers are satisfied that a 30mph Speed Limit be imposed on the M77 / A77 Glasgow – Stranraer Trunk Road at Girvan to include the access to Girvan Community Hospital within the speed restriction, improving road safety and the environment for pedestrians and other road users accessing the Community Hospital.

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 82(2)(b), 83(1), and 124(1)(d) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

They have complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b).

Citation and commencement

1. This Order may be cited as the A77 Trunk Road (Girvan) (Restricted Roads) Order 2011 and comes into force on 28th March 2011.

Direction that a length of road shall become a restricted road

2. It is directed that the length of road specified in the Schedule to this Order shall become a restricted road for the purposes of section 81 of the 1984 Act.

Variation of previous Order

3. (1) The Trunk Roads (Restricted Roads) (Ayrshire) Order 1975(a) is varied to the effect that paragraph 2b of the Schedule to that Order is revoked.

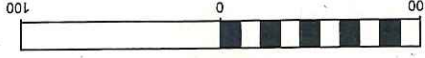
