### **ROAD TRAFFIC**

The A76 Trunk Road (Glenairlie Improvement) (50mph Speed Limit) Order 2009

<i>Made</i>	<i>05 January 2009</i>
<i>Coming into force</i>	<i>16 January 2009</i>

The Scottish Ministers, make the following Order in exercise of the powers conferred by section 84(1)(a) and 124(1)(d) of the Road Traffic Regulation Act 1984(a), and all other powers enabling them in that behalf.

They have complied with Part II of the Secretary of State's Traffic Orders (Procedure) (Scotland) Regulations 1987(b), before making this Order.

#### **Citation and commencement**

1. This Order may be cited as the A76 Trunk Road (Glenairlie Improvement) (50mph Speed Limit) Order 2009 and comes into force on 16 January 2009.

#### **Restriction of speed**

2. No person shall drive any motor vehicle at a speed exceeding 50mph on the lengths of road specified in the Schedule to this Order.

#### **Revocation of previous order**

3. The A76 Trunk Road (Mennock) (50mph Speed Limit) Order 1998 made on 26 February 1998 is revoked.

**SCHEDULE**

- (i) That length of A76 Trunk Road in Mennock from a point 132 metres or thereby northwest of the centreline of its access to Mennock Bridge Cottage southeastwards to a point 333 metres or thereby southeast of the southeastern boundary of Ulva Cottage, a distance of 611 metres or thereby.
- (ii) That length of the B797 Mennock - Leadhills - Abington Road from a point 170 metres or thereby northwest of the centreline of where the B797 intersects with the centreline of the Kilmarnock to Dumfries railway line in a north westerly and then westerly direction to its intersection with the A76 Trunk road, a distance of 86 metres or thereby.
