**ROAD TRAFFIC**

**The M8 Motorway(Junction 20, West Street, to Junction 24, Helen Street) (Temporary 50mph Speed Limit) Revocation Order 2011**

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1), 4(1), 14(1) and (4), and 124(1)(d) of, and paragraph 27 of Schedule 9 of the Road Traffic Regulation Act 1984(a), and of all other powers enabling them to do so.

**Citation and commencement**

1. This Order may be cited as the M8 Motorway (Junction 20, West Street, to Junction 24, Helen Street) (Temporary 50mph Speed Limit) Revocation Order 2011 and comes into force on 2nd May 2011.

**Revocation**

2. The M8 Motorway (Junction 20, West Street, to Junction 24, Helen Street) (Temporary 50mph Speed Limit) Order 2010(b) is revoked.

THE SCOTTISH MINISTERS give notice that they have made the above Order revoking the M8 Motorway (Junction 20, West Street, to Junction 24, Helen Street) (Temporary 50mph Speed Limit) Order 2010. The revocation has effect from 2nd May 2011.

From 2nd May 2011 a permanent 50mph speed limit will be in operation on the above length of road by virtue of The Glasgow Renfrew Motorway (Stages I and II) (Speed Limit) Amendment Regulations 2011.
