CONSULTATION QUESTIONS

Question 1: do you agree with the proposal to extend the pre-registration notice period from 14 days to 28 days ?

Yes X No

This proposal to increase the pre-registration period will be useful for LTAs that have commercial services operating within their boundary. This may allow additional time to assess the impact of commercial operator's decisions to alter or cancel bus services and thus allowing options for LTA to take action if required.

This proposal has little relevance to registered local bus services operated within the Western Isles as all the public bus services are under contract with the Comhairle whose transport staff centrally control bus service registrations. It is highly unlikely that a commercially operated local bus service would be viable within the Western Isles.

Question 2: Do you agree with the proposal to replace the duty to inform the relevant authorities before making an application for registration with a duty to consult with the relevant authorities?

We would agree with this proposal to consult as it may encourage a collaborative approach between commercial operators and transport authorities. Additional guidance on the level of information exchanged during the consultation phase would be needed to get a satisfactory understanding of any impact to the travelling public brought about through registration changes.

Question 3: Do you agree that relevant authorities should be encouraged through guidance to draw potential concerns about new registrations to the attention of the traffic Commissioner for Scotland and/or Transport Scotland?

We agree with this proposal in principal but again there would need to be guidance of registration proposals that fall into a category that may cause concern to either the quality of the service offered to the passengers or unfair competitive timetables that are aimed at reducing the revenue income of a commercial or subsidised competitor. We are unsure of the Traffic Commissioners remit and powers to decline a such a registration.

Question 4a: Do you agree with the proposal to reduce the period of registration from 56 days to 42 days? What difficulties (if any) do you consider such a change might present and how might these be addressed?

As the Comhairle control all bus service registrations a reduction in the formal notification period would be welcomed allowing important service changes to be implemented 14 days earlier.

We would prefer that the proposed reduction to the registration period be applied to both paper form and EBSR applications.

Question 5: Do you agree that we should require operators to detail within registered hourly frequency bands any services that are registered as frequent services?

In the context of commercial bus operations this proposal would benefit the travelling public by providing better travel information. This may also be useful to routes with RTI systems. All registrations co-ordinated by the Comhairle include the entire service timetable.
