

PRESS NOTICE

THE A86 TRUNK ROAD (SPEAN BRIDGE) (TEMPORARY PROHIBITION ON USE OF ROAD) ORDER 2017

THE SCOTTISH MINISTERS give notice that they have made the above Order under section 62(1) of the Roads (Scotland) Act 1984, temporarily prohibiting traffic on the A86 Spean Bridge – Kingussie Trunk Road from a point about 500 metres or thereby west of its junction with the access road to Ardverikie House, Kinloch Laggan in an easterly direction to a point about 500 metres east of said junction with the access road to Ardverikie House, Kinloch Laggan, a total distance of 1 kilometre or thereby.

The Order, which is required to allow filming of the road to take place will be in force from 21st April 2017 to 27th April 2017 but will only have effect when indicated by the appropriate traffic signs. It is anticipated that the restrictions will be in place for a short period of no more than 15 minutes at some point during the hours of 08:00 and 19:00 on 26th April 2017. The date is subject to change or cancellation. The Order does not apply to vehicles while being used in an emergency for fire brigade, coastguard, ambulance or police purposes or to acts done with the permission or upon the direction of a police constable in uniform.

ALTERNATIVE ROUTES

An alternative route for traffic during the prohibition is not required.

ROAD TRAFFIC

The A86 Trunk Road (Spean Bridge) (Temporary Prohibition of Traffic) Order 2017

Made - - - - *11th April 2017*

Coming into force - - *21st April 2017*

The Scottish Ministers make the following Order in exercise of the powers conferred by section 62(1) of the Roads (Scotland) Act 1984^(a) and all other powers enabling them to do so.

In accordance with section 62(1) of that Act, they are of the opinion that considerations of public safety or convenience require that traffic should be temporarily prohibited on the length of road specified in the schedule while filming on the road takes place.

Citation, commencement and cessation

1. This Order may be cited as the A86 Trunk Road (Spean Bridge) (Temporary Prohibition of Traffic) Order 2017, comes into force on 21st April 2017 and ceases to have effect on 27th April 2017.

Prohibition on use of vehicles

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of the length of road, specified in the schedule of this Order when a prohibition is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 8 (diagram 7105 – position of barrier to mark length of road closed or to guide traffic past an obstruction) of the sign table in Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016^(b).

Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle being used in an emergency for fire brigade, ambulance, police or coastguard purposes; or
- (b) a vehicle being used in connection with the filming on the road; or

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

That length of the A86 Spean Bridge – Kingussie Trunk Road from a point 500 metres or thereby west of its junction with the access road to Ardverikie House, Kinloch Laggan in an easterly direction to a point 500 metres or thereby east of said junction with the access road to Ardverikie House, Kinloch Laggan, a total distance of 1 kilometre or thereby.
