The Access Rights over those parts of the New Works Site shown shaded light green and bounded by a red line including the red line shall be restricted to servitude rights or wayleaves for the purposes of construction and maintenance of field access works and associated works only

The Access Rights over those parts of the New Works Site shown shaded purple and bounded by a red line including the red line shall be restricted to authorised bat workers for the purposes of maintenance of the existing bat house.

The Access Rights over those parts of the New Works Site shown shaded brown and bounded by a red line including the red line shall be restricted to temporary access for the purposes of construction of temporary road diversions and associated works only. The Access Rights over those parts of the New Works Site shown cross-hatched in red and bounded by a red line including the red line shall not be for the purposes of using the part of the site so defined for temporary storage of materials or as a site compound.
