

LABEL NOTES

1. WHERE THE CABINET CONTAINS LASER OPERATED EQUIPMENT (i.e FIBRE OPTIC EQUIPMENT) THEN THE LASER SYMBOL LABEL AS FIG.1 TO BE FITTED TO BOTH DOORS AS BS 5378 PART 1
2. THE ELECTRICAL SYMBOL LABEL AS FIG. 2 TO BE FITTED TO BOTH DOORS ON ALL ELECTRICALLY ENERGISED CABINETS AS BS 5378 PART 1.
3. THE CABINET ID LABELS SHALL BE PRINTED ON SELF ADHESIVE MATERIAL BLACK PRINTING ON A WHITE BACKGROUND AND BE FIXED AS FOLLOWS:
 - a/ BEFORE ATTACHING THE LABEL TO THE CABINET SURFACE CLEAN THE AREA WITH ISOPROPANOL OR EQUIVALENT CLEANING FLUID TO REMOVE OIL, GREASE AND DIRT.
 - b/ ENSURE THE SURFACE TO WHICH THE LABEL IS TO BE ATTACHED IS SMOOTH AND WITHOUT CORROSION OR DAMAGE.
 - c/ TO FIX, REMOVE THE BACKING FROM THE PRINTED LABEL AND POSITION BEFORE PRESSING FIRMLY AND EVENLY OVER THE WHOLE LABEL.
4. TO CREATE THE CORRECT CHAINAGE VALUE FOR USE ON THE IDENTIFICATION LABEL, DIVIDE THE DISTANCE IN METRES, BETWEEN THE SITE AND THE AGREED ZERO POINT, BY 10, TO PRODUCE A FOUR DIGIT NUMBER.
5. EQUIPMENT IDENTIFIERS FOR USE ON THE LABEL SHALL BE AGREED WITH THE OVERSEEING ORGANISATION PRIOR TO MANUFACTURE
6. ALL LABELLING SHALL BE IN ACCORDANCE WITH THE SHW SERIES 1500 (SCOTLAND) AND CONFORM TO ALL SPECIFIC REQUIREMENTS OF THE CONTRACT.
7. CHARACTER SIZE AND FINAL POSITION ON THE CABINETS SHALL BE AGREED WITH THE OVERSEEING ORGANISATION PRIOR TO LABELS BEING INSTALLED.
