The A96 Trunk Road (Inverurie Road) (Redetermination of Means of Exercise of Public Right of Passage) Order 2017

The Scottish Ministers have made the following order in exercise of the powers conferred by sections 2(1) and 152(2) of the Roads (Scotland) Act  $1984(\mathbf{a})$  and all other powers enabling them to do so.

#### Citation and commencement

**1.** This Order may be cited as the A96 Trunk Road (Inverurie Road) (Redetermination of Means of Exercise of Public Right of Passage) Order 2017 and comes into force on 25th July 2017.

#### Redetermination of means of exercise of public right of passage

**2.** The length of road in the Bucksburn area of Aberdeen specified in the schedule of this Order at present a carriageway shall become a cycle track, the right of passage being exercisable on pedal cycle and foot only.



# ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED

That length of the A96 Aberdeen – Inverness Trunk Road being the lay-by adjacent to the westbound carriageway from a point 370 metres or thereby northwest of the point where the circulatory carriageway of the A96 forms a junction with Sclattie Park to a point 518 metres or thereby northwest of that junction with Sclattie Park, a distance of 148 metres or thereby, as shown by saw tooth hatching and marked on plan numbered RD01 and entitled "The A96 Trunk Road (Inverurie Road) (Redetermination of Means of Exercise of Public Right of Passage) Order 2017".
