DISABLED PERSONS' PARKING PLACES (SCOTLAND) ACT 2009 ANNUAL REPORT ON LOCAL AUTHORITIES' FUNCTIONS

1 APRIL 2016 TO 31 MARCH 2017

Background:

The Disabled Persons' Parking Places (Scotland) Act 2009¹ ("the Act") was passed by the Scottish Parliament on 26 February 2009, receiving Royal Assent on 1 April 2009, and coming into force on 1 October 2009. The Act places a duty on all local authorities to promote the proper use of disabled parking places, and aims to make all disabled persons' parking bays enforceable.

Under the Act, local authorities have duties to identify all advisory disabled parking places and either remove them or begin the statutory procedure to make them enforceable. The Act states that this duty was to be performed within 12 months of the coming into force of the Act (by 30 September 2010).

The Act also places a duty on local authorities under section 11 and the Scottish Ministers under section 12 to publish annual performance reports. Part 1 and Part 2 of the Schedule² to the Act details what the reports should include.

Local Authorities' Duty under section 11:

Section 11 of the Act requires a local authority to prepare, publish and send to Scottish Ministers a copy of, 'a report on its performance of its functions in relation to parking places for disabled persons' vehicles during the reporting period.' Part 1 of the Schedule specifies what information the report should contain.

Scottish Ministers' Duty under section 12:

Section 12 of the Act requires Scottish Ministers to prepare, publish and lay before the Scottish Parliament, 'a report on the performance by the local authorities of their functions in relation to parking places for disabled persons' vehicles during the reporting period.'

Part 2 of the Schedule to the Act details what the Scottish Ministers should include in their report. This is provided at **Annex A for reporting period 2016/17**.

The preparation, publication and laying of this report will fulfil those requirements for the reporting year 2016/17 and cover the period from 1 April 2016 to 31 March 2017. The Scottish Ministers' reports are published on the Transport Scotland website³.

ANNEX A

SCOTTISH MINISTERS' REPORTING DUTIES:

The following information is reported as a requirement of section 12 of the Act. The following information should be read in conjunction with the Schedule⁴ to the Act.

1. <u>Schedule, Part 2, paragraph 3 (a):</u> 'details of the action that each local authority took in fulfilment of its duty under section 1'.

Local authorities reported the following information under paragraph 3 (a) in respect of the reporting period:-

Aberdeen City Council:

- Aberdeen City Council continues to process applications for disabled persons' parking places where criteria are met. Advisory disabled persons' parking places are provided until the statutory process is completed.
- The Council also removes any disabled persons' parking place that is no longer required;
- Blue Badge holders, when requesting a disabled persons' parking place, are fully advised of the regulations, that they are open to any Blue Badge holder and that the badge requires to be displayed at all time;
- The Council enforces all disabled persons' parking places governed by a traffic regulation order and has an officer in place to investigate fraudulent use of Blue Badges.

Aberdeenshire Council:

- Aberdeenshire Council promotes the proper use of disabled persons' parking places by routinely issuing excess charge notices to those using such spaces improperly in car parks covered by the Aberdeenshire Council (Off-Street Parking) Order;
- The number of such notices issued during the reporting period (2016-17) was 133 of which 39 were subsequently cancelled following successful appeals.

Angus Council:

- Angus Council are continuing to process applications for new on-street disabled persons' parking places and where criteria is met then advisory bays are provided until the statutory process is completed. Disabled persons' parking places which are no longer required are removed;
- The Council issued 4 penalty charge notices to those drivers improperly using disabled persons' parking places in a Council operated off-street public car park during 2016-2017 reporting period;
- In the 2016-2017 reporting period. The Council concluded the decriminalised parking enforcement process. On 3 May 2017, the responsibility for parking enforcement passed from Police Scotland to Angus Council;
- The Council has promoted a single Order for on-street disabled persons' parking places covering the whole of the Angus Council area;

• The Council also promoted an off-street car parks Order which comprises all Council operated public car parks. Within that Order provision for the enforcement of disabled persons' parking places located within those car parks was included.

Argyll & Bute Council:

• 2 bays identified and marked out.

City of Edinburgh Council:

- Every two years City of Edinburgh Council send out a letter to all non-domestic rates payers and organisations explaining the key points of the Disabled Persons' Parking Places (Scotland) Act 2009 and asking for confirmation if any have a car park with disabled persons' parking places and if they wish the Council to enforce such places;
- In October 2016, 19,130 such letters were sent. Of the 2,299 returns received before the closing date, 27 were expressions of interest from businesses with an off-street car park looking for enforcement. The Council has not yet followed these up;
- In addition, staff within Parking Operations and the Localities Offices provide advice and the relevant application form to customers who wish to apply for a disabled persons' parking place outside their home;
- For new developments there are procedures in place to make the developer aware of the duty of local authorities to promote the proper use of disabled persons' parking places. As part of the planning process the developer is asked if they wish the Council to enforce disabled persons' parking places.

Clackmannanshire Council:

- Clackmannanshire Council progressed five traffic orders in the reporting year;
- Work is ongoing to consolidate traffic orders by Town.

Comhairle nan Eilean Siar:

• In March 2017, Comhairle nan Eilean Siar started the process to create a traffic regulation order in respect of 9 disabled persons' parking places. This would combine the existing 13 disabled persons' parking places from an order in 2014 with the 9 additional disabled persons' parking places.

Dumfries & Galloway Council:

- Dumfries & Galloway Council processes disabled persons' parking places applications as and when received;
- The Council also reviews traffic regulation orders periodically.

Dundee City Council:

- Information is available on the Dundee City Council website relating to the scheme, rights and responsibilities of Blue Badge holders;
- Press publications have also been released informing motorists of the increased budget made available to meet standards and maintain existing disabled persons' parking places.

East Ayrshire Council:

- As a decriminalised parking enforcement authority East Ayrshire Council's Parking Attendants are vigilant to misuse of disabled persons' parking places onstreet and off-street;
- Parking Attendants are also well versed on the misuse of Blue Badges;
- The Council's offices multi-storey car park display information notices (supplied by Scottish Government) regarding the use of disabled persons' parking places;
- Application Forms and Qualifying Criteria for a disabled person's parking place are available on-line from the Council's web pages.

East Dunbartonshire Council:

- East Dunbartonshire Council continue to promote the proper use of disabled persons' parking places as required through the Disabled Persons' Parking Places (Scotland) Act 2009;
- In October 2016, a two week publicity and enforcement campaign was run to raise awareness around the misuse of Blue Badges. This campaign involved the Council's Parking Attendants conducting checks on Blue Badges and challenging those persons' in possession of a Blue Badge without entitlement;
- During the campaign, a total of 62 badges were inspected with 7 of these being seized. A post campaign press release was issued to reinforce the issue of misuse to the public and make them aware that the Council will utilise its powers to confiscate badges where they are being abused;
- During the reporting period, the Council have reported one individual to the Procurator Fiscal for the misuse of a Blue Badge. During the reporting period a total of 118 Penalty Charge Notices (PCNs) were issued for the offence of being parked in a designated disabled persons' parking place without a valid Blue Badge. The majority of offences of this nature take place within Town Centre locations. Of the 118 PCNs issued, 31 were in residential areas;
- A programme of continued enforcement will further deter misuse of designated disabled parking bays within East Dunbartonshire.

East Lothian Council:

• Advertising Literature, "Don't park in my space" has been displayed in all East Lothian Council offices.

East Renfrewshire Council:

- In order to fulfil East Renfrewshire Council's duty under section 1 of the Disabled Persons' Parking Places (Scotland) Act 2009 the Council considered the method best suitable for delivering and maintaining disabled persons' parking places within East Renfrewshire.
- An electronic system to record locations of all enforceable disabled persons' parking places, both on-street and off street, has been designed and is continuously maintained by the Council.
- Promotion of updated traffic regulation orders, one for on-street and one for offstreet, has commenced and these Orders are anticipated to come into effect by later this year.

Falkirk Council:

- Falkirk Council considered all requests for disabled persons' parking places by qualifying persons and has where possible commenced the statutory process to make traffic regulation orders for those applicants.
- The Council has developed its own Performance Indicator to monitor the period of time to process applications for on-street disabled persons' parking places.

Fife Council:

- Fife Council made the eighth amendment to the on-street traffic order on 24 May 2016 and made the ninth amendment on 12th October 2016. This is part of the 6 monthly updates carried out by the Council;
- The traffic regulation order was amended on each occasion to add new disabled persons' parking places and to remove those which are no longer required.

Glasgow City Council:

• The Council continued to receive and grant applications for the provision and repaint of disabled parking bays by qualifying persons.

Highland Council:

• All approved disabled persons' parking places across the Highlands have been included in a proposed traffic regulation order for decriminalised parking enforcement, but have not completed the statutory process as yet.

Inverclyde Council:

- Inverclyde Council promotes the creation of parking places for disabled persons through an on-line application process on the Council's website;
- With the introduction of decriminalised parking enforcement throughout Inverclyde, traffic orders were created to regulate off-street car parks and include disabled persons' parking places;
- Consultation and publicity processes served to highlight the provision of disabled persons' parking places within the car parks.

Midlothian Council:

- Midlothian Council process new applications as fast as resources permit;
- The Council completed the legal process for 128 disabled persons' parking places in 2016-2017.

Moray Council:

- Following the process undertaken previously, to identify all historic advisory disabled parking spaces, Moray Council has assessed all new applications received in the reporting period (2016-2017), in accordance with the Disabled Persons' Parking Places (Scotland) Act 2009 and supporting advice;
- The Council's Traffic and the Blue Badge Teams continue to provide ad-hoc advice on the use of disabled persons' parking places.

North Ayrshire Council:

• North Ayrshire Council provides a sign and pole in the vicinity of the disabled persons' parking places to show that bays are enforceable;

- When a disabled persons' parking place has been approved a letter is sent out informing the applicant that enforcement should be carried out by Police Scotland;
- The Council has issued a letter to a large housing association in the area inviting them to be included in the Council's next Order.

North Lanarkshire Council:

- North Lanarkshire Council has continued to assess requests for disabled persons' parking places and promoted a number of traffic regulation orders to allow the use of parking spaces to be enforced by Police Scotland;
- Advisory road markings have been placed at requested locations initially and will remain in place until procedures to promote traffic regulation orders are complete, allowing permanent traffic signs and markings to be installed.

Orkney Islands Council:

• Orkney Council has identified both on-street and off-street parking places.

Perth & Kinross Council:

• Perth and Kinross Council has identified disabled persons' parking place for enforcement purposes.

Renfrewshire Council:

- Renfrewshire Council has made its third and fourth on-street disabled persons' parking places traffic regulation orders and has started work on a fifth, during the reporting period 2016-2017. The Council is also working on its first off-street disabled persons' parking places traffic regulation order;
- The Council's third traffic regulation order includes an additional 119 new disabled persons' parking places while removing 40 disabled persons' parking places that were no longer required;
- The forth traffic regulation order includes an additional 76 new disabled persons' parking places while removing 15 disabled persons' parking places that were no longer required;
- The Council is now drafting a fifth on-street traffic regulation order and its first offstreet Order which includes 30 new disabled persons' parking places. The Council's original approach to the landowner was declined because the land was in private ownership, but the Council is now requested to cover these private disabled persons' parking places with a traffic regulation order.

Scottish Borders Council:

• None.

Shetland Islands Council:

- Shetland Islands Council has provided information through various sources in order to reach as many in the community as possible. This includes:
 - the council web page, highlighting eligibility, statutory process and all relevant information;
 - local weekly newspaper (The Shetland Times), to highlight all stages of the statutory process;

• all new developments are encouraged to participate in the provision of disabled parking bays where necessary.

South Ayrshire Council:

- South Ayrshire Council has published information on Council web site;
- The Council has promoted a traffic regulation order covering proper use of onstreet disabled persons' parking places;
- The Council has trained Parking Attendants to promote proper use of disabled persons' parking places and Blue Badges, through education and enforcement.

South Lanarkshire Council:

• South Lanarkshire Council enforces the regulated disabled persons' parking places in line with its policies and procedures.

Stirling Council:

- Stirling Council continues to assess all applications received for a disabled person's parking places under criteria which was amended following the introduction of the Disabled Person's Parking Places (Scotland) Act 2009, within 10 working days whenever possible;
- Where an applicant meets the criteria for a disabled persons' parking space outside their property, the Council will aim to arrange for the road markings to be installed for an advisory disabled person's parking place, within 10 working days of receiving their agreement on its location;
- Once the traffic regulation order process has been completed, the Council will arrange for the necessary signage to be erected;
- On completion of the traffic regulation order the applicant's details are entered into a database to ensure a complete record is maintained;
- The Council's traffic regulation orders and parking policy continue to allow vehicles displaying a Blue Badge to park free of charge and without time limit within any on-street or off-street pay and display parking area, in addition to any designated disabled persons' parking places.

West Dunbartonshire Council:

- West Dunbartonshire Council maintains an up-to-date database for all on-street disabled persons' parking places, which identifies those already legally enforceable and those which are currently advisory only;
- The database is continually updated to include all new on-street disabled persons' parking places;
- Each time a new amendment to the traffic regulation order is implemented, the disabled persons' parking places marked as advisory are automatically included.

West Lothian Council:

- West Lothian Council has provided information through various sources in order to reach as much of the community as possible. The following methods have been used to convey information:
 - o information on the council web page at all times;
 - the back doors of the Council's vans have been vinyl wrapped with a message promoting the correct use of disabled persons' parking places.

2. <u>Schedule, Part 2, paragraph 3 (b):</u> 'the total number of parking places designated by the local authorities as being for use only by a disabled persons' vehicle by virtue of the provisions of this Act (except section 9)'

Table 1 below sets out the total number of parking places (excluding temporary places) designated by individual local authorities as being for use only by a disabled person's vehicle, as reported. The table reports only new disabled parking places made enforceable by an order in the reporting year 2015/16 and does not take account of those removed.

The following information has been provided by the local authorities mentioned below:

Clackmannanshire Council:

"Clackmannanshire Council are a small local authority where we do not have parking enforcement. We are still processing traffic regulation orders due to staffing levels and workloads, these are taking time.

Budget wise we only put plates up where disabled persons' parking places are getting misused or in busy areas."

Comhairle nan Eilean Siar :

"A traffic regulation order (TRO) in 2014 focussed on disabled persons' parking places within the Stornoway town centre which were upgraded to meet the required standard. Since then a number of additional parking places have been considered for inclusion on the latest TRO started in March 2017. Following some consultation and inspection only 9 have been included in the latest TRO. This includes disabled persons' parking places in Tarbert, Harris. All of the 9 disabled persons' parking places are "off street". Following the present TRO it is hoped that a future TRO will include disabled persons' parking places throughout the Western Isles."

East Dunbartonshire Council:

"East Dunbartonshire Council, with agreement through our Legal Services team, have agreed to promote traffic regulation orders for all on-street disabled persons' parking places on an annual basis. Removals will be progressed every two years.

During the reporting period, the Council have legally designated a further 70 onstreet disabled persons' parking places through the East Dunbartonshire Council (Designated Disabled Persons' Parking Places & Amendments) Order 2016. This Order became effective as of the 25 July 2016."

East Renfrewshire Council;

"Due to other obligations & commitments and available resources, it has not been possible to promote an update to the current traffic regulation orders (TRO):

- The East Renfrewshire Council (Disabled Persons' Parking Bays) (On-Street Parking) Order 2015
- The East Renfrewshire Council (Disabled Persons' Parking Bays) (Off-Street Parking) Order 2015

It is anticipated the on-street TRO will be replaced with the promotion of an updated TRO or an amendment to the existing TRO later this year.

However, the East Renfrewshire Council (Off-Street Parking Places) Order 2017 was promoted under sections 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and came into effect in May 2017. Although this TRO was not promoted solely to control the abuse of off-street disabled persons' parking places, it enables enforcement of 138 marked/signed disabled persons' parking places in car parks included in the TRO if the bays are occupied by a vehicle not properly displaying a valid disabled persons' blue badge."

Falkirk Council:

"Falkirk Council designates temporary parking places by marking a bay on the carriageway. Once the TRO has been made, the associated traffic sign is erected.

Falkirk Council will contact those Developers that have received Planning Permission relating the relevant business types during the 2016/2017 financial year to determine whether they wish TRO's to be promoted. There have been 33 bays provided over 7 separate developments.

Section 8 of the 2009 Act requires local authorities to determine the locations of advisory disabled persons' parking bays in off-street car parks biennially. Falkirk Council will undertake this exercise this financial year."

Highland Council:

"The Highland Council continues to roll out decriminalised parking enforcement (DPE) in 2017. Town centres all over the Highland area have seen an increase in on-street disabled persons' parking places. All of these newly added disabled persons' parking places will be included in a traffic regulation order and will conform to The Traffic Signs Regulations and General Directions 2016 specification."

Inverclyde Council:

"16 disabled persons' parking places started the statutory procedure before the start of the reporting period and were revoked within the period.

20 disabled persons' parking places started the statutory procedure and were revoked within the period.

9 disabled persons' parking places started the statutory procedure to be revoked.

There are 456 current disabled persons' parking places which have been created by means of an Order since April 1996. This is in addition to the 40 created during this reporting period."

Moray Council:

"A survey will be undertaken during Autumn 2017 when staff resources permit with 1100 local businesses to determine if they are willing to enter into an agreement with Moray Council to introduce enforceable off-street disabled persons' parking places. Previous returns have indicated that no proprietors wish to take up this service to create a legally enforceable traffic regulation order for their premises, but the results for this year will be reported in the next submission."

Renfrewshire Council:

"Renfrewshire Council continues to carry out its duties under the Disabled Person's Parking Places (Scotland) Act 2009 as indicated."

Shetland Islands Council:

"Generally speaking we contact an applicant within 1 week to clarify qualification and identify a suitable area for the disabled persons' parking places and begin the process.

As the local planning consent regulations do not stipulate a set number of disabled parking spaces in new developments, we find no apatite from them to enter into an agreement with the Shetland Islands Council to start the statutory process."

West Dunbartonshire Council:

"The 2015/16 traffic regulation order (TRO) for on-street disabled persons' parking places was delayed until October 2016 due to a sustained objection resulting in a hearing, which was found in favour of the Council. This delay resulted in the 2016/17 TRO not being made at all. The process to make the 2017/18 TRO will commence shortly and will include the disabled persons' parking places intended to be included in the 2016/17 TRO."
