COMPULSORY PURCHASE ORDER 201[ ]**

Notice is hereby given that the Scottish Ministers in exercise of the powers conferred by the above mentioned Acts, on the Twenty Eighth day of November Two Thousand and Seventeen prepared the above mentioned Compulsory Purchase Order which affects the land described in the Schedule hereto, for the purpose of improving and constructing new lengths of the M9/A9 Edinburgh – Stirling – Thurso Trunk Road between Killiecrankie and Glen Garry.

The Order is about to be made and comes into operation only if made. If the Order is made, a conveyance registered in implement of the Order may vary or extinguish rights to enforce real burdens and servitudes affecting the land.
