

**ACQUISITION OF LAND (AUTHORISATION PROCEDURE) (SCOTLAND) ACT 1947**

**THE A9 TRUNK ROAD (TOMATIN TO MOY) (EXTINGUISHMENT OF PUBLIC RIGHT OF WAY) ORDER 201[ ]**

NOTICE IS HEREBY GIVEN that the Scottish Ministers, in exercise of the powers conferred on them by section 3 of the Acquisition of Land (Authorisation Procedure) (Scotland) Act 1947(a) propose to make the above-mentioned Order extinguishing certain public rights of way in the County of Inverness-shire and providing alternative public rights of way, as described in the Schedule hereto.

## **SCHEDULE**

### **PART 1**

#### **PUBLIC RIGHT OF WAY TO BE EXTINGUISHED**

A length of the existing public right of way, heading in a generally north western direction from the unnamed track south west of the existing A9 Trunk Road tying in with the existing Forestry Road.

### **PART 2**

#### **ALTERNATIVE RIGHT OF WAY TO BE PROVIDED**

A public right of way heading in a generally north western direction from the unnamed track south west of the existing A9 Trunk Road tying in with the existing Forestry Road.

### **PART 3**

#### **PUBLIC RIGHTS OF WAY TO BE EXTINGUISHED FOR WHICH AN ALTERNATIVE IS NOT REQUIRED**

1. A public right of way heading in a generally south eastern direction south of Moybeg Cottage and north and parallel with the A9 Trunk Road.
2. A public right of way heading in a generally western then south western direction south of the A9 Trunk Road and east of the U2864 Lynbeg Road.
