# Disabled Persons' Parking Places (Scotland) Act 2009 Annual Report on Local Authorities' Functions

## 1 April 2017 to 31 March 2018

# **Background**

The Disabled Persons' Parking Places (Scotland) Act 2009<sup>1</sup> ("the Act") was passed by the Scottish Parliament on 26 February 2009, receiving Royal Assent on 1 April 2009, and coming into force on 1 October 2009. The Act places a duty on all local authorities to promote the proper use of disabled parking places, and aims to make all disabled persons' parking bays enforceable.

Under the Act, local authorities have duties to identify all advisory disabled parking places and either remove them or begin the statutory procedure to make them enforceable. The Act states that this duty was to be performed within 12 months of the coming into force of the Act (by 30 September 2010).

The Act also places a duty on local authorities under section 11 and the Scottish Ministers under section 12 to publish annual performance reports. Part 1 and Part 2 of the Schedule<sup>2</sup> to the Act details what the reports should include.

## Local Authorities' duty under section 11

Section 11 of the Act requires a local authority to prepare, publish and send to Scottish Ministers a copy of, 'a report on its performance of its functions in relation to parking places for disabled persons' vehicles during the reporting period.' Part 1 of the Schedule specifies what information the report should contain.

# Scottish Ministers' duty under section 12

Section 12 of the Act requires Scottish Ministers to prepare, publish and lay before the Scottish Parliament, 'a report on the performance by the local authorities of their functions in relation to parking places for disabled persons' vehicles during the reporting period.'

Part 2 of the Schedule to the Act details what the Scottish Ministers should include in their report. This is provided at Annex A for reporting period 2017/18.

The preparation, publication and laying of this report will fulfil those requirements for the reporting year 2017/18 and cover the period from 1 April 2017 to 31 March 2018. The Scottish Ministers' reports are published on the Transport Scotland website<sup>3</sup>.

# **Scottish Ministers' reporting duties:**

The following information is reported as a requirement of section 12 of the Act. The following information should be read in conjunction with the Schedule<sup>4</sup> to the Act.

1. <u>Schedule, Part 2, paragraph 3 (a):</u> 'details of the action that each local authority took in fulfilment of its duty under section 1'.

Local authorities reported the following information under paragraph 3 (a) in respect of the reporting period:-

#### **Aberdeen City Council:**

- Aberdeen City Council continues to process applications for disabled persons' parking places where criteria are met. Advisory disabled persons' parking places are provided until the statutory process is completed
- The Council also removes any disabled persons' parking place that is no longer required
- Blue Badge holders, when requesting a disabled persons' parking place, are fully advised of the regulations, that they are open to any Blue Badge holder and that the badge requires to be displayed at all time
- The Council enforces all disabled persons' parking places governed by a traffic regulation order and has officers in place to investigate fraudulent use of Blue Badges.

#### **Aberdeenshire Council:**

- Aberdeenshire Council promotes the proper use of disabled persons' parking places by routinely issuing excess charge notices to those using such spaces improperly in car parks covered by the Aberdeenshire Council (Off-Street Parking) orders
- The number of such notices issued during the reporting period (2017-18) was 77 of which 16 were subsequently cancelled following successful appeals

#### **Angus Council:**

 Angus Council are continuing to process applications for new on-street disabled persons' parking places and where criteria is met then advisory bays are provided until the statutory process is completed. Disabled persons' parking places which are no longer required are removed.

- On 3 May 2017 the responsibility for parking enforcement was passed from Police Scotland to Angus Council under Decriminalised Parking Enforcement (DPE) legislation
- The Council made a single DPE Order for on-street disabled persons' parking places covering the whole of the Angus Council area
- The Council made a single DPE Order for off-street disabled persons' parking places covering the whole of the Angus Council area
- The Council made a DPE off-street car parks Order which comprises all Council
  operated public car parks. Within that Order provision for the enforcement of
  disabled persons' parking places located within those car parks were included.

#### **Argyll & Bute Council:**

- Three new on-street disabled persons' parking places (by Order) made on 19 March 2018
- In late March 2018 an additional three requests were received

#### **City of Edinburgh Council:**

- Staff within Parking Operations and the Localities Offices provide advice and the relevant application form to customers who wish to apply for a disabled persons' parking place outside their home
- For new developments there are procedures in place to make the developer aware of the duty of local authorities to promote the proper use of disabled persons' parking places. As part of the planning process the developer is asked if they wish the Council to enforce disabled persons' parking places.

#### **Clackmannanshire Council:**

- Clackmannanshire Council progressed six traffic orders in the reporting year
- Work is ongoing to update records for all towns/villages

#### **Comhairle nan Eilean Siar:**

A new traffic regulation order has been advertised in the local press and Council
website in March 2018 relating to additional disabled persons' parking places.
 This new order incorporates disabled persons' parking places already included in
a previous order.

#### **Dumfries & Galloway Council:**

- Dumfries & Galloway Council processes disabled persons' parking places applications as and when received
- The Council also reviews traffic regulation orders periodically

#### **Dundee City Council:**

- Information is available on the Dundee City Council website relating to the scheme, rights and responsibilities of Blue Badge holders
- Press publications have also been released informing motorists of the increased budget made available to meet standards and maintain existing disabled persons' parking places

#### **East Ayrshire Council:**

- As a decriminalised parking enforcement authority East Ayrshire Council's Parking Attendants are vigilant to misuse of disabled persons' parking places onstreet and off-street
- Parking Attendants are also well versed on the misuse of Blue Badges
- The Council's offices multi-storey car park displays information notices (supplied by Scottish Government) regarding the use of disabled persons' parking places
- Application forms and qualifying criteria for a disabled person's parking place are available online from the Council's web pages

#### **East Dunbartonshire Council:**

- East Dunbartonshire Council continue to promote the proper use of disabled persons' parking places designated for the leaving of a vehicle displaying Blue Badges as required through the Disabled Persons' Parking Places (Scotland) Act 2009
- The Council have recently revised parking charge tariffs for Council car parks.
   While Blue Badge holders will continue to be exempt from charges, as part of the
   social media campaign and press release in the lead up to the introduction of the
   new charging tariff, we decided to remind Blue Badge holders of the requirement
   to properly display a valid Blue Badge while parked in a disabled persons parking
   place
- During the reporting period, a total of 170 Penalty Charge Notices (PCNs) were issued for the offence of being parked in a designated disabled persons' parking place without a valid Blue Badge

#### **East Lothian Council:**

 Advertising literature, "Don't park in my space" has been displayed in all East Lothian Council offices

#### **East Renfrewshire Council:**

- In order to fulfil East Renfrewshire Council's duty under section 1 of the Disabled Persons' Parking Places (Scotland) Act 2009, the Council considered the method best suitable for delivering and maintaining disabled persons' parking places within East Renfrewshire
- An electronic system to record locations of all enforceable disabled persons' parking places, both on-street and off street, has been designed and is continuously maintained by the Council
- Traffic regulation orders for on-street and off-street disabled persons' parking places are promoted enabling enforcement of marked bays

#### **Falkirk Council:**

 Falkirk Council considered all requests for disabled persons' parking places by qualifying persons and has where possible commenced the statutory process to make traffic regulation orders for those applicants

#### Fife Council:

- Fife Council made the eleventh amendment to the on-street traffic order on 17
  January 2018 and made the tenth amendment on 5 April 2017. This is part of the
  six monthly updates carried out by the Council
- The traffic regulation order was amended on each occasion to add new disabled persons' parking places and to remove those which have since become redundant

#### **Glasgow City Council:**

- Glasgow City Council continued to receive and grant applications for the provision and repaint of disabled persons' parking places by qualifying persons
- All new developments have been checked and where necessary developers will be contacted and invited to participate

#### **Highland Council:**

No response received

#### **Inverclyde Council:**

- Inverclyde Council promotes the creation of parking places for disabled persons' through an online application process on the Council's website
- With the introduction of decriminalised parking enforcement throughout Inverclyde, traffic orders were created to regulate off-street car parks and include disabled persons' parking places
- Consultation and publicity processes served to highlight the provision of disabled persons' parking places within the car parks

#### Midlothian Council:

- All pre-existing on-street disabled persons' parking places have been identified, assessed and made enforceable by inclusion in a traffic regulation order
- All off-street disabled persons' parking places for which the Council is responsible for have been identified, assessed and made enforceable by inclusion in a traffic regulation order
- New applications are being processed as fast as resources permit
- As a decriminalised parking area, the enforcement of disabled persons' parking places is the responsibility of the Council

## **Moray Council:**

- Following the process undertaken previously, to identify all historic advisory disabled persons' parking places, Moray Council has assessed all new applications received in the reporting period (2017-2018), in accordance with the Disabled Persons' Parking Places (Scotland) Act 2009 and supporting advice
- The Council's Traffic and the Blue Badge Teams continue to provide ad-hoc advice on the use of disabled persons' parking places

#### **North Ayrshire Council:**

- North Ayrshire Council provides a sign and pole in the vicinity of the disabled persons' parking places to show that bays are enforceable
- When a disabled persons' parking place has been approved a letter is sent out informing the applicant that enforcement should be carried out by Police Scotland
- The Council's Roads department has held meetings with the Council's Housing department and relevant Housing Associations to look at standardising application forms and procedures and to encourage them to include their disabled persons' parking places in the next Traffic Order as 'off-street' parking places

#### **North Lanarkshire Council:**

- North Lanarkshire Council has continued to assess requests for disabled persons' parking places and promoted a number of traffic regulation orders to allow the use of parking spaces to be enforced by Police Scotland
- Advisory markings have been placed at requested locations initially and will remain in place until procedures to promote traffic regulation orders are complete allowing permanent signs and markings to be provided

#### **Orkney Islands Council:**

 Orkney Council has identified both on-street and off-street disabled persons' parking places

#### Perth & Kinross Council:

 Parking Attendants regularly inspect and enforce the disabled persons' parking places to ensure the proper use of the parking places

#### **Renfrewshire Council:**

- Renfrewshire Council is currently dealing with objections to proposals in its fifth disabled persons' parking places on-street Order
- The Council has also made its first off-street Order in October 2017
- The fifth on-street traffic regulation order proposes to provide an additional 125 new disabled persons' parking places while none were removed
- The Council is also working on its sixth on-street traffic regulation order with 101 new bays at present

#### **Scottish Borders Council:**

 Scottish Borders Council has provided advisory on-street and off-street disabled persons' parking places, provided enforceable off-street disabled persons' parking places through traffic regulation orders, enforced off-street parking regulations and encouraged on-street enforced by Police.

#### **Shetland Islands Council:**

Shetland Islands Council has provided information through various sources in order to reach as many in the community as possible. This includes:

 the council web page, highlighting eligibility, statutory process and all relevant information

- local weekly newspaper (The Shetland Times), to highlight all stages of the statutory process
- all new developments are encouraged to participate in the provision of disabled parking bays where necessary

#### **South Ayrshire Council:**

- South Ayrshire Council has published information on the Council's web site
- The Council has promoted a traffic regulation order covering proper use of onstreet disabled persons' parking places
- The Council has trained Parking Attendants to promote proper use of disabled persons' parking places and Blue Badges, through education and enforcement

#### **South Lanarkshire Council:**

 South Lanarkshire Council enforces the regulated disabled persons' parking places in line with its policies and procedures

#### **Stirling Council:**

- Stirling Council continues to assess all applications received for disabled person's parking places under criteria which was amended following the introduction of the Disabled Person's Parking Places (Scotland) Act 2009, within ten working days whenever possible
- Where an applicant meets the criteria for a disabled persons' parking place outside their property, the Council will aim to arrange for the road markings to be installed for an advisory disabled person's parking place, within ten working days of receiving their agreement on its location
- Once the traffic regulation order process has been completed, the Council will arrange for the necessary signage to be erected
- On completion of the traffic regulation order the applicant's details are entered into a database to ensure a complete record is maintained
- The Council's traffic regulation orders and parking policy continue to allow vehicles displaying a Blue Badge to park free of charge and without time limit within any on-street or off-street pay and display parking area, in addition to any designated disabled persons' parking places
- In January 2018 the Council sent out an initial letter to everyone with a disabled persons' parking place as at December 2016, advising them of our requirement to review that they continued to meet the criteria for such a space. A second

letter was issued to the people who did not respond in March 2018 and a further check was made with our Finance Services to check on non-returns.

 The Council initially wrote out to 176 address, from these, 64 spaces are due to be revoked and six require further investigation. The traffic regulation orders required to revoke the disabled persons parking space will be processed in 2018/19.

#### West Dunbartonshire Council:

- West Dunbartonshire Council maintains an up-to-date database for all on-street disabled persons' parking places, which identifies those already legally enforceable and those which are currently advisory only
- The database is continually updated to include all new on-street disabled persons' parking places
- Each time a new amendment to the traffic regulation order is implemented, the disabled persons' parking places marked as advisory are automatically included

#### **West Lothian Council:**

West Lothian Council has provided information through various sources in order to reach as much of the community as possible. The following methods have been used to convey information:

- information on the Council web page at all times
- the back doors of the Council's vans have been vinyl wrapped with a message promoting the correct use of disabled persons' parking places

2. Schedule, Part 2, paragraph 3 (b): 'the total number of parking places designated by the local authorities as being for use only by a disabled persons' vehicle by virtue of the provisions of this Act (except section 9)'

Table 1 below sets out the total number of parking places (excluding temporary places) designated by individual local authorities as being for use only by a disabled person's vehicle, as reported. The table reports only new disabled parking places made enforceable by an order in the reporting year 2017/18 and does not take account of those removed.

Whilst some local authorities did not report any additional information by reference to Part 1, paragraph 2 to the Act, those who did reported a range of information including clarifications on what activity took place in performing its duties under the Act or what activities are planned for the next reporting year.

18 out of the 31 local authorities (no response was received from Highland Council) who provided a return did not report any 'other information' under this paragraph. Those local authorities are:

Aberdeen City Council, Aberdeenshire Council, Angus Council, City of Edinburgh Council, Dumfries & Galloway Council, Dundee City Council, East Ayrshire Council, East Lothian Council, Falkirk Council, Fife Council, North Lanarkshire Council, Orkney Islands Council, Perth & Kinross Council, Scottish Borders Council, South Ayrshire Council, South Lanarkshire Council, West Dunbartonshire Council and West Lothian Council.

The following information has been provided by the local authorities mentioned below:

#### **Argyll and Bute Council:**

"As with other local authorities, the budget reductions faced by Argyll and Bute Council over the last ten years or so have resulted in a smaller workforce and a reduced ability to process requests as quickly as we would want. It may provide betterment if the legislation could be amended so that any disabled bays appropriately marked and signed were automatically enforceable. It would be a vast improvement even if this was only applied to off-street disabled bays."

#### **Clackmannanshire Council:**

"Clackmannanshire Council are a small local authority where we do not have parking enforcement. We are still processing traffic regulation orders due to staffing levels and workloads, these are taking time.

Budget wise we only put plates up where disabled persons' parking places are getting misused or in busy areas."

#### Comhairle nan Eilean Siar:

"At present a traffic regulation order is being processed which will include a total of 22 enforceable spaces. Initially it was hoped to have more bays in this order but on inspection these bays were not suitable for inclusion. The order now includes bays out with Stornoway town centre."

#### **East Dunbartonshire Council:**

"It should be noted that, in duties under Section 5(d)(iv), the 45 spaces where the process was started under section 5(3)(b) pertain to those which were identified in the previous reporting period (1 April 2016 – 31 March 2017).

At the time of submission, the return was incomplete as information from East Dunbartonshire Council's Planning Section had not yet been received in order to complete the Duties under Section 7 of the report."

#### **East Renfrewshire Council:**

"Due to other obligations & commitments and available resources, it has not been possible to promote an update to the current traffic regulation orders (TROs).

However, the promotion of an updated on-street TRO for 2018 has commenced and is anticipated to come into effect later in 2018."

#### **Glasgow City Council:**

"The Council intends instigating discussions with Transport Scotland to seek to allow disabled bays to have the same status as bus stops, that is when they are signed on road they become enforceable."

#### **Inverclyde Council:**

"Nine disabled persons' parking places started the statutory procedure before the start of the reporting period and were revoked within the period.

Seven disabled persons' parking places started the statutory procedure and were revoked within the period.

Seven disabled persons' parking places started the statutory procedure to be revoked.

There are 566 current disabled persons' parking places which have been created by means of an Order since April 1996. This is in addition to the 40 created during this reporting period."

#### Midlothian Council:

"Midlothian Council has been able to continue the employment of a member of staff specifically dealing with progressing traffic regulation orders. This has meant that three traffic regulation orders for a total of 117 disabled persons' parking places was completed in 2017/18.

A steady stream of new applications is being received from disabled people who are experiencing difficulty in parking close to their homes (122 applications during 2017/2018).

Businesses in Midlothian were contacted during Autumn 2017 regarding disabled persons' parking places. No requests for Midlothian Council to enforce disabled persons' parking places in private premises were received during the consultation.

The new Act placed considerable extra responsibilities on local authorities. No additional funding was made available for signs and lines. However the Council is still able to assess applications reasonably quickly and the disabled persons' parking places are generally painted on the ground quite quickly depending on the availability of the road marking contractor. In most cases the presence of the initial "advisory" disabled road markings is enough to resolve any parking issues. At the beginning of April, Midlothian became a decriminalised parking area. Midlothian Council are now responsible for parking enforcement, including the enforcement of disabled persons' parking places."

#### **Moray Council:**

"Due to staff shortages a traffic regulation order (TRO) has not been commenced yet to formalise all advisory disabled persons' parking places created during the reporting period. It is anticipated that this will commence in August 2018.

Once started it will have taken approximately 16 months to commence the process to introduce a TRO to make all new advisory spaces, created during the reporting period, legally enforceable and remove those spaces that have become redundant. It remains our intention to repeat this process every Autumn when resources permit."

#### **North Ayrshire Council:**

"In the last reporting period North Ayrshire Council has undergone some reorganisation and the function of looking after disabled persons' parking places has transferred to a new member of staff, this has led to delays in starting the traffic regulation order to add the approved disabled persons' parking places since the last Order.

However, progress has been made with Housing colleagues who administer disabled persons' parking places not on the adopted road network to align procedures to make it seamless for the applicants as to how they apply and having the provided disabled persons' parking places enforceable under a Traffic Order. Similar work has been ongoing with a large Housing Association."

#### **Renfrewshire Council:**

"Renfrewshire Council continues to carry out its duties under the Disabled Person's Parking Places (Scotland) Act 2009 as indicated."

#### **Shetland Islands Council:**

"We recognise the problems many applicants have with increasing parking issues and we therefore contact an applicant almost immediately (within 1 week) to clarify qualification requirements and identify a suitable area for the space and begin the process.

As the local planning consent regulations do not stipulate a set number of disabled persons' parking places in new developments, we find no apatite from them to enter into an agreement with us (Shetland Islands Council) to start the statutory process."

#### **Stirling Council:**

"To continue to liaise with Stirling Area Access Panel with regards disabled parking provision, whether that be new spaces or improvements to existing spaces on or off street.

Progress with respect of taking forward disabled persons' parking places implement and future enforcement within private car parks needs further analysis, and is still to be carried out, which is dependent on staff resources." 7. Schedule Part 2, paragraph 4: 'A report prepared by the Scottish Ministers under section 12(1)(a) may contain any other information about the performance by local authorities of their functions in relation to parking places for disabled persons' vehicles during the reporting period that the Scottish Ministers consider appropriate'
