1 Foreword

Transport Scotland was allocated over £2.4 billion from the Scottish budget during 2017/2018 to deliver a safe, efficient, cost-effective and sustainable transport system for the benefit of the people of Scotland. Transport Scotland plays a key role in helping to achieve the Scottish Government's purpose of increasing sustainable economic growth with opportunities for all of Scotland to flourish.

While a large part of this budget is allocated to other public and private sector organisations through grants and support, Transport Scotland's procurement spend during 2017/2018 was more than £830 million on contracts under its management.

Procurement underpins much of the delivery of Transport Scotland's priorities and has a notable impact on performance and success. In recognition of the wider impact that procurement policy and practice has on the Scottish Government's purpose and Transport Scotland's commitments, our vision for procurement is:

"To support the delivery of value for money, sustainable and innovative infrastructure and services in fulfilment of the Scottish Government's ambition and vision for transport, and Transport Scotland's corporate commitments through a strategic and systematic approach to procurement."

As an agency of the Scottish Government, Transport Scotland's Annual Procurement Report 2018, demonstrates how we support the Scottish Government's goals of increasing competitiveness and tackling inequality, ensuring that Transport Scotland makes the best use of public money and takes account of its legal obligations.

2 Executive summary

Transport Scotland's Annual Procurement Report demonstrates how we support the Scottish Government's overall procurement aims to deliver sustainable inclusive economic growth though achieving value for money, quality and sustainability.

During the reporting period Transport Scotland has undertaken 58 regulated procurements with a value of over £155 million and this Annual Procurement Report demonstrates how we have undertaken these in accordance with the commitments previously made in in Transport Scotland's Procurement Strategy 2017-2020.

Our focus has been to undertake these procurements in a sustainable manner that complies with legislation and governance. We have added value through our procurements and maintained a high standard of capability by implementing best practice and continuous improvement.

This has resulted in the delivery of a wide range of community benefits, provision of opportunities for small and medium-sized enterprises (SMEs) and supported businesses, a commitment to using project bank accounts for works contracts greater than £10 million, as well as updates to our governance procedures. We have utilised existing frameworks and collaborative contracts to secure savings to the public purse as well as making sub-contract opportunities available on Public Contracts Scotland.

Going forward, Transport Scotland will continue to develop its procurement capability to ensure a strategic and systematic approach to procurement, and maintain a high standard of procurement capability. Transport Scotland is investigating ways to further increase community engagement, provide improved community benefits, and further develop its engagement with the third sector and supported businesses.

3 Introduction

Procurement is integrated into the project management process in Transport Scotland and consequently this activity is not undertaken by a centralised procurement function. Instead it is carried out in a devolved manner by staff with appropriate skills and expertise who are members of project teams across the organisation.

Transport Scotland has a clearly defined governance structure in place to support the procurement activity undertaken by the agency. Transport Scotland's Chief Executive (Roy Brannen) is the accountable officer who is responsible for the propriety, effectiveness, efficiency and economy of procurement activity within the agency. The Chief Executive has appointed the Director of Purchasing (Michelle Rennie) to hold purchasing authority for all procurement relating to the management and operation of Transport Scotland. The Director of Purchasing has been given authority to sub-delegate purchasing authority to members of project teams within Transport Scotland as considered appropriate. The Director of Purchasing is supported in her duties by the Deputy Director of Purchasing (Graham Porteous). The Director of Purchasing meets biannually with the Director of Procurement and Commercial (Ainslie McLaughlin) from the Scottish Government's Scottish Procurement and Commercial Directorate to discuss procurement-related issues.

Transport Scotland's Procurement Team report to the Deputy Director of Purchasing and they play a central role in the agency's procurement activity by providing support and advice to members of project teams.

As required under section 15 of the Procurement Reform (Scotland) Act 2014 ("the Act"), a contracting authority must publish a Procurement Strategy by December 2016 and subsequently produce an Annual Procurement Report, required by section 18 of the Act. The Annual Procurement Report monitors the authority's regulated procurement activities against delivery of its Procurement Strategy and should be published as soon as is reasonably practicable after the end of their financial year.

This is Transport Scotland's first Annual Procurement Report. The content of this report covers all regulated procurements completed during the period 1 January 2017 to 31 March 2018 and details how those procurements supported the objectives included within the Transport Scotland Procurement Strategy 2017 to 2020. Transport Scotland's subsequent Annual Procurement Reports will monitor the delivery each financial year.

A regulated procurement¹ is any procurement for public supplies or services with a value of £50,000 or above. For works this value is £2,000,000 or above. This is true for both contracts and framework agreements. Transport Scotland completed 14 regulated procurements and 44 call-offs from framework agreements during the reporting period.

¹ A regulated procurement is completed when the award notice is published or where the procurement process otherwise comes to an end.

4 Summary of regulated procurement

Transport Scotland's regulated procurements are governed by the policies and procedures described in the <u>Transport Scotland Procurement Strategy 2017-2020</u>.

Between 1 January 2017 and 31 March 2018, Transport Scotland completed 14 discrete regulated procurements. Transport Scotland makes use of framework agreements where appropriate and 44 regulated procurements were called-off from framework agreements during the reporting period, 36 of which were from existing frameworks. Transport Scotland utilises existing Transport Scotland frameworks, Scottish Government frameworks and UK frameworks where appropriate, as well as procuring new framework agreements for works, services and supplies where required.

Table 1 summarises Transport Scotland's regulated procurement activity within the reporting timeframe by the type of procurement procedure undertaken. The total value of these procurements is over £115 million.

Further detail on the procurements referred to in Table 1 is contained within Appendix A.

Where possible, Transport Scotland seeks to avoid the use of Non-Competitive Actions (NCAs) and has developed procedures to ensure that requests for NCAs are made only on an exceptional basis, in writing, clearly recording the grounds for the request. Only one regulated procurement was undertaken during the reporting period by means of an NCA. This had a total value of £86,000, which equates to 0.01% of Transport Scotland's procurement spend.

During the reporting period the Procurement Team verified new contract notices prior to publication, to ensure that any contract notice developed in Public Contracts Scotland included the relevant commitments made in the Procurement Strategy. Transport Scotland paid 96% of our suppliers within ten days during the reporting period.

5 Review of regulated procurement compliance

Transport Scotland made four procurement commitments in section six of its Transport Scotland Procurement Strategy 2017-2020.

The four commitments are:

- Undertake Transport Scotland procurements in a sustainable manner
- Ensure Transport Scotland procurements comply with relevant EU and national legislation and internal policy and governance procedures
- Add value through Transport Scotland procurements and promote collaborative procurement opportunities where appropriate to ensure Transport Scotland contracts represent value for money
- Maintain a high standard of procurement capability across Transport Scotland through the implementation of best practice and continuous improvement

These commitments were sub-divided into 30 delivery sub-actions. Table 2 shows progress against each of the 30 delivery sub-actions:

6 Summary of community benefits

The Procurement Reform (Scotland) Act 2014 stipulates that community benefits must be considered for all procurements greater than £4 million. In the reporting period 5 of the 14 regulated procurements contained community benefits considerations. These were:

- Engineering and Technical Consultancy Services Interim PAG Service
- Transport Data Collection Services
- A737 Dalry Bypass

Transport Scotland also delivered community benefits on contracts which were live during the reporting period. These included the provision of more than 260 apprenticeships, 54 work placements, 140 graduate places and over £570 million of work sub-contracted through Public Contracts Scotland (including over £183 million subcontracted to SMEs) over the duration of these contracts.

In the future, Transport Scotland will ensure that community benefit requirements continue to be considered in its procurements. Transport Scotland is also developing systems to more consistently record benefits across the range of procurements it undertakes.

Appendix B shows examples that demonstrate the range of benefits delivered on different types of Transport Scotland contacts over their duration.

7 Supported businesses summary

Transport Scotland ensures that supported businesses are considered when a new procurement strategy is developed. Transport Scotland spent over £10,500 in direct spend with supported businesses during the reporting period for the following activities:

- Supply of personal protective equipment from Haven PTS
- Printing of the Road Safety Scotland biannual magazine by Haven Products
- Supply of promotional material used at Meet the Buyer and Procurex by Haven Products

The use of supported businesses is promoted by Transport Scotland at their regular feedback meetings with their suppliers. Transport Scotland's suppliers have placed a number of sub-contracts with supported businesses, with a value of over £165,000. These include:

- Cfine for the supply of foodstuffs for the Northern Isles Ferry Services contract
- Glencraft for the supply of mattresses for the Northern Isles Ferry Services contract
- Glencraft for the supply of bespoke bedding for the Caledonian Sleeper contract
- The Sign Factory who supplied road signs for the A737 Dalry By-Pass
- Haven Sign Factory, Haven Printing & Mailing and Haven Recycling who provided goods and services for the Clyde and Hebrides Ferry Services contract

- Eight project staff signed up to become science, technology, engineering and mathematics (STEM) ambassadors committed to engaging with young people to inform and encourage them into careers in science, technology, education and mathematics by sharing their own skills, experience and interests in these areas.
- A foodbank collection initiative was organised to assist North Ayrshire Foodbank. The project donated four boxes of food items prior to Christmas.
- Police Scotland Ayrshire Division met with workers at the site of the new A737 Dalry Bypass to discuss the aims of the 'White Ribbon' campaign and to encourage workers to sign the campaign pledge 'never to commit, excuse or remain silent about violence against women'. Police Scotland highlighted the rise in violence against both men and women and asked the team to support them in getting the message out that violence of any kind is unacceptable.



## A9 Dualling: Kincraig to Dalraddy

- The project delivered a refurbished playground, as agreed with the Highland Council, in return for areas of school land which were required to be given up to facilitate the dualling project. The new school playground has transformed the original facilities to provide an attractive area with a climbing wall and multi-use, allweather games area.
- Waste material produced during site clearance activities saw vegetation donated to the Highland Wildlife Park to provide animal food and furnishings for the enclosures.
- A working relationship has been established to the mutual benefit of both the Wildlife Park and the project, with many more items donated including old traffic cones, drainage pipe offcuts and large brushes from road-sweepers, all used to help provide a stimulating environment for the animals.

- Transport Scotland's technical advisors have donated to foodbanks in Huntly and Inverurie.

- Transport Scotland's technical advisors have helped to provide STEM training to over 400 pupils from schools in the Moray area.

- 224 job starts were provided by the project, 56 of whom were previously employed in the oil and gas industry. Of these, 55 were from Aberdeenshire.
- The value of contracts awarded to Scottish SMEs and Social Enterprises was excess of £65 million, which is circa 12% of the total value of contracts awarded.
- 69 SME's were awarded over 10% of the contracts on the project.
- The project engaged with almost 10,000 school pupils by providing project update presentations and providing information on environmental, geological, structural and road works disciplines in line with the Curriculum for Excellence portfolio. Career-ready and industry awareness sessions were made available for students.
- A 'Skills Pledge' to develop the skills and qualifications of its workforce, supply chain and local community was signed by the contractor. Regular toolbox talks along with competency, training and engagement programmes were undertaken.
- The Office of National Statistics demonstrate that women are under-represented in the UK construction industry workforce. However, the Aberdeen Western Peripheral Route/Balmedie to Tipperty scheme had above average statistics, with 215 females working on the project. This represented 14% of the overall workforce and women were involved in 65% of site based roles. These included roles such as plant operator, geologist, engineer, laboratory technician, environmental scientist, planner, security and general construction operative.

#### Examples of the type of community benefits delivered

The ferry operator undertook a variety of activities which contributed towards community benefits in the community and the environment including:

- Supporting careers advice events at local schools.
- Providing 53 work vocational places (i.e. apprenticeships; training for unemployed and work placements). Of these, 20 full time places were aimed at priority groups, including young people, unemployed and disadvantaged.
- Encouraging supported businesses through the procurement process and using local suppliers. £7,515 was spent with the third sector and supported businesses.
- Creating a resident's focus group of 70 volunteers. This provides a voice for communities on the ferry routes to feedback on strategic issues.
- Initiating a marine awareness programme. This results in vessels being used to undertake marine biodiversity monitoring, passenger engagement and education about the marine environment. Visitors and locals are informed how to facilitate better information sharing between conservation agencies.
- An ORCA wildlife officer has been on-board vessels from February 2018 to undertake passenger engagement.

- Scottish firms were awarded sub-contracts or supply orders on the Forth Replacement Crossing Project with a total value circa £351 million out of a total circa £709 million (49.5%).
- 55,860 out of a total of 60,596 supply orders (92%) were awarded to Scottish companies with a value circa £163 million out of a total of circa £215 million (76%).
- 818 workers undertook or completed vocational training as a result of the project. The annual average was 103 people undertaking training compared to the minimum contractual requirement of 45.
- Professional support was provided to pupils/students through engagement with educational establishments. "Crossing the Black Water", a series of Science, Technology, Engineering, Arts and Mathematics (STEAM) workshops for Primary 7 pupils was created in a partnership between Fife Council Economic Development, CCD Training, Fife Tourism Partnership and Forth Crossing Bridge Constructors. The workshops informed young people about the history and construction of the Forth bridges and highlighted the wide range of different careers and disciplines involved in constructing the bridges.
- Since the Contact and Education Centre opened its doors in 2013, a total of over 83,000 people, including 25,000 school pupils, have visited the building to see the project exhibition, listen to presentations by project staff or take part in a variety of construction and engineering skills challenges.
- Transport Scotland arranged a series of engagement events for Summer 2018 to encourage young people to look at the engineering involved in the Queensferry Crossing and to consider a future in engineering and STEM related careers, helping Scotland to bridge the skills gap. These included events which were specifically aimed at young women and girls.

- A 'Skills Pledge' to develop the skills and qualifications of its workforce, supply chain and local community was undertaken by the contractor. Regular toolbox talks along with an on-going competency, training and engagement programme was undertaken and necessary health and safety qualifications were issued.
- A local charity required a replica of a World War One trench for its showpiece exhibit at the Ideal Home Show. Project staff were pleased to help and donated timber to construct the trench. The charity subsequently received £10,000 of other donations from those who visited the exhibit.

• The Contractor delivered a six day working field course, which provided hands-on construction experience for students and young professionals to link the world of academic theory with Contractors and Consultants from industry. It aimed to develop practical skills, knowledge and experience of students by exposing them to working on a real construction site on a live project. Nine female engineers working on the project signed up to the STEM Ambassadors Programme to engage and enthuse young women in particular about Science, Technology, Engineering and Mathematics.

## Examples of the type of community benefits delivered

- Ten apprentices are participating in training programmes, as well as being offered the opportunity to complete the Duke of Edinburgh Scheme Gold Award.
- The franchisee held two recruitment workshops at Scottish prisons during the year. This resulted in two work placements being made available for offenders.
- The franchisee offered free courses in interview skills and employer awareness sessions to over 100 Scottish veterans, service leavers and unemployed reservists who were registered with organisations that support the ex-serving communities in Scotland.
- £1 million was invested through the Stations Community Regeneration Fund which is designed to revitalise old railway stations, support local business and community groups for the benefit local people. A £200,000 enterprise fund was made available to support business start-up schemes in stations.
- The franchisee offers at least five school leavers per year the opportunity to complete a certificate of work readiness while completing a five week placement.

The franchisee has an Environmental and Energy Policy, invested £100,000 in a Sustainability Innovation Fund, achieved 1022 tonnes of CO2 reduction, installed 100 electric vehicle charge points at stations, and saved nearly 4000 tonnes of water. Trains have now been fitted with tanks to keep sewage off the tracks.

- Sub-contract opportunities resulted from the services provided. Serco NorthLink Ferries have increased their 50 mile local spend from Contract Year 1 (2012) to Contract Year 6 (2018) by 68%. These areas include Aberdeen, Kirkwall, Hatston, Lerwick, Stromness and Scrabster.
- 24 new intakes to the marine industry have been given full Standards of Training, Certification and Watch-keeping training.

#### Examples of the type of community benefits delivered by each operating company

- As a minimum, an average of 10% of all new recruits are described as new entrants. New entrants are individuals who are new to the construction industry, or who have been out of work for six months or more. All new entrants have either an apprenticeship, trainee or employment contract with the operating company.
- During each annual period the operating company ensures, as a minimum:
  - that either two members of existing staff or two new recruits are trained in a relevant qualification to Scottish Vocational Qualifications Level 2 or equivalent.
  - that either one member of existing staff or one new recruit is undertaking relevant professional training.
  - provision of three work experience placements in accordance with the requirements of the Work Experience element of the UK Government's Get Britain Working policy. All travel costs incurred by each person undertaking a work experience placement are paid by the operating company.

- Academy9 is an education initiative led by Transport Scotland, linked specifically to the A9 Dualling Programme. It is hoped that it will encourage pupils of schools on the Perth to Inverness corridor to consider STEM related careers.
- The Academy9 team met with the Glasgow Gaelic School to discuss translating some of the roadshow material into Gaelic in order for it to be used in the Gaelic schools around Scotland.
- Transport Scotland's technical advisors held a workshop to prepare S5 and S6 pupils at Breadalbane Academy for the workplace. This included giving them interview and CV tips as well information about different types of jobs and routes to further. Three sessions were held on interview techniques (good and bad), CV and personal statement writing, speed networking with the professionals.
- The Academy9 team was invited to present at the STEM 2018 conference, held in Holyrood, Edinburgh. The attendees were mainly teachers, pupils and education practitioners keen to understand the future of STEM and activities currently underway to support pupils into STEM related careers.
- Since the initiative's launch, the Academy9 team has carried out over 750,000 hours of pupil learning.
