Forth Replacement Crossing – Fife ITS Contract

Update on Intention to Progress Site Works – Gantry Number 20F A92 Crossgates

Further to previous communications, I can confirm that works are progressing steadily at various locations on the road network corridor associated with the Fife ITS Contract.

I thought it appropriate to write and provide an update on our intentions with regards to construction works specifically associated with Gantry 20F on the A92 southbound carriageway adjacent to Alice Grove and Westfield Grove, Crossgates.

Typical work activities at this location includes preliminary site clearance, provision of temporary accesses, mine consolidation works, piling works, concrete foundations, maintenance hard-standings, road surfacing, safety barriers and erection of gantries during spring of 2012.

Due to the uncertainties inherent with historical mine workings we can only estimate extent of consolidation works required however based on our current programme, we anticipate that these works could potentially be completed in around 3 weeks.

Site clearance is ongoing, accesses to the road verges have been established and piling works will continue on completion of the consolidation works.

These works have been carefully programmed in partnership with Transport Scotland, Fife Council, Forth Estuary Transport Authority (FETA), the Police and emergency services, to minimise traffic disruption and impact on surrounding areas.

As intimated previously, we shall continue to monitor our activities and potential construction impacts, and take all reasonable steps to minimise disturbance. In this regard, noise monitoring equipment shall be installed week commencing Monday 30th January 2012 to ensure ongoing compliance.
